NOTICE is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of:-

- (i) Church Street between and including the junctions of Queen Elizabeth Road and Orchard Hill; and
- (ii) Queen Elizabeth Road between Church Street and Pathfield Close; and
- (iii) Queen Elizabeth Road on the north side at the junction with Tates Way; and
- (iv) Tates Way north of Queen Elizabeth Road.

The consultations for these proposals will start on 16 June 2022 and, AT THAT TIME, full details of the proposals in this Notice can be viewed on our website www.westsussex.gov.uk/tro. The [website](#) includes a response form for comments or objections.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of:-

- (i) Church Street between and including the junctions of Queen Elizabeth Road and Orchard Hill; and
- (ii) Queen Elizabeth Road between Church Street and Pathfield Close; and
- (iii) Queen Elizabeth Road on the north side at the junction with Tates Way; and
- (iv) Tates Way north of Queen Elizabeth Road.

Church Street is a "B" classified residential road providing connections to a number of other residential roads and to Rudgwick Primary School. The local community have expressed concerns that the levels of on-street parking restricts visibility for vehicles exiting and approaching road junctions and could impede access for emergency vehicles.

To alleviate the problem, it is proposed to introduce lengths of double yellow lines on sections of Church Street between Queen Elizabeth Road and Orchard Hill, on Queen Elizabeth Road between Church Street and Pathfield Close and also at the junction of Tates Way and, on Tates Way north of Queen Elizabeth Road.

This will remove the obstruction caused by parked vehicles and better manage access and egress for vehicles.

This Order is proposed for avoiding danger to persons or traffic using the road and to facilitate the passage on the road of any class of traffic and for facilitating the passage on the road of any class of vehicle (including pedestrians).

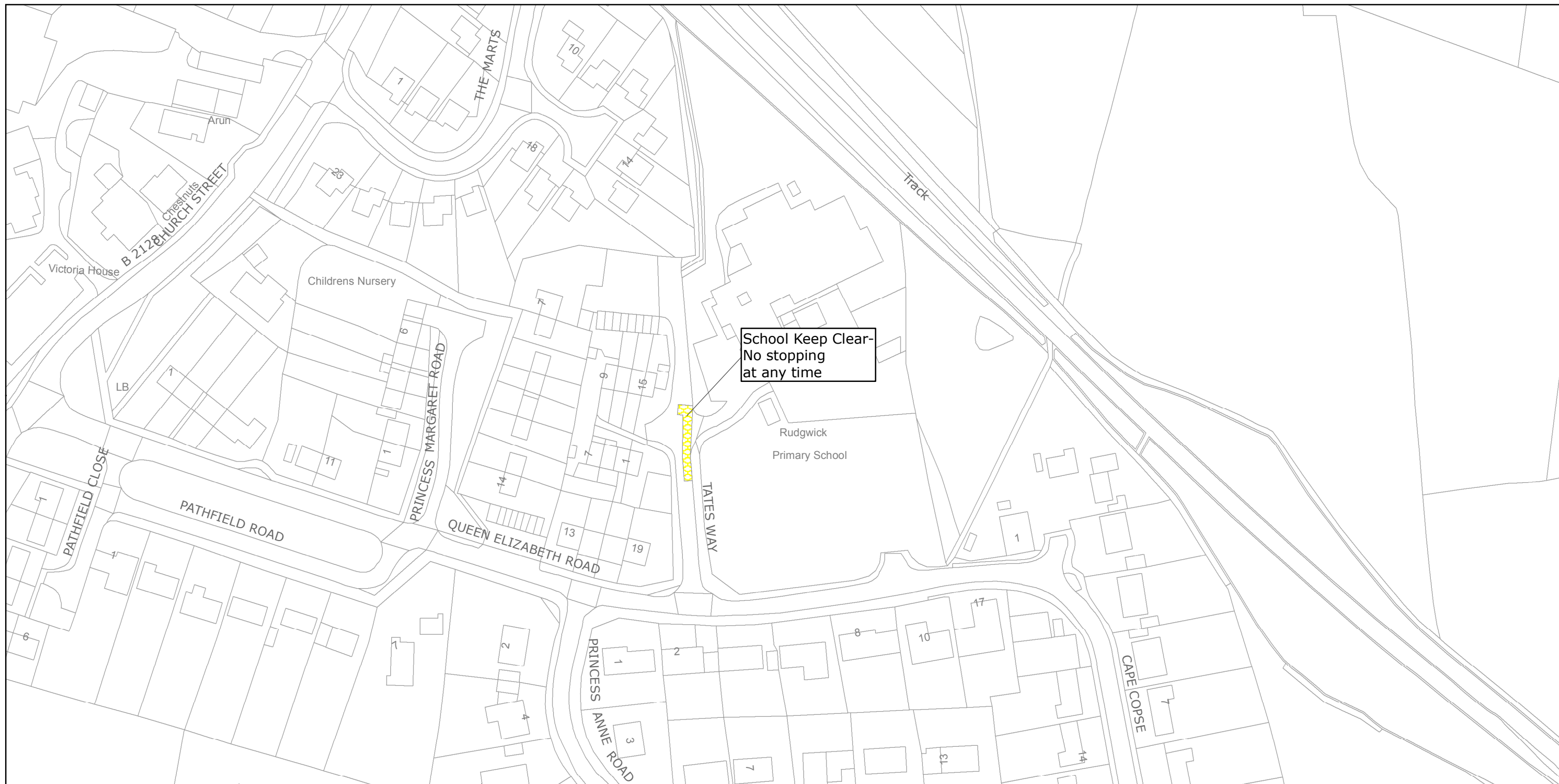

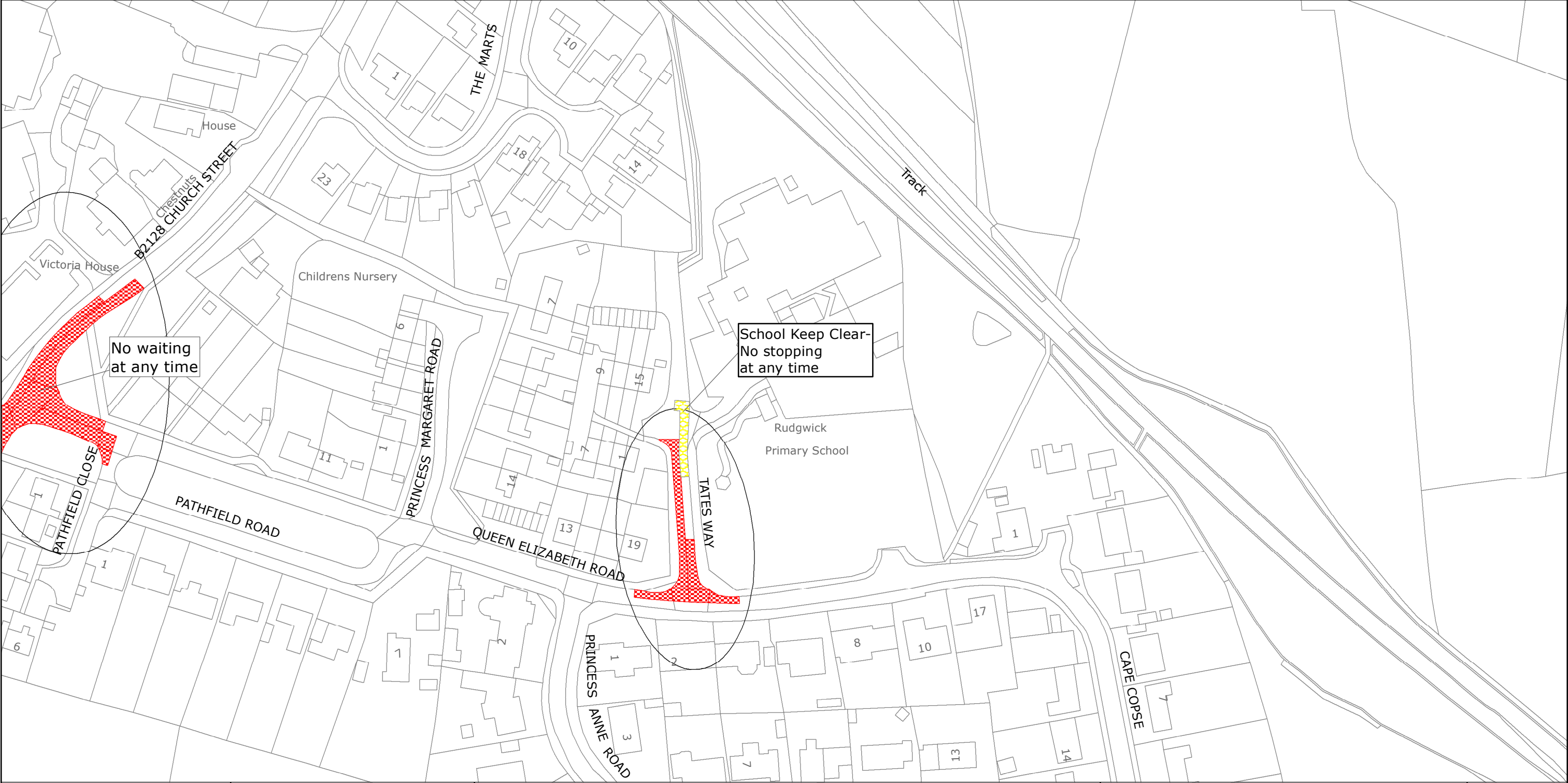
