**NOTICE** is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce a 40mph speed limit on the A283 Shoreham Road, from High Trees roundabout junction to a point 48 metres south of the southern junction with Dacre Gardens and to extend the 40mph speed limit on the A2037 to High Trees roundabout junction.

The consultations for these proposals will start on 30 November 2023 and, AT THAT TIME, full details of the proposals in this Notice can be viewed on our website [www.westsussex.gov.uk/tro](http://www.westsussex.gov.uk/tro). The website includes a response form for comments or objections.

**(40MPH SPEED LIMIT) ORDER 2023**

**Statement of reasons for proposing to make the Order**

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce a 40mph speed limit on the A283 Shoreham Road, from High Trees roundabout junction to a point 48 metres south of the southern junction with Dacre Gardens and to extend the 40mph speed limit on the A2037 to High Trees roundabout junction.

The section of the A283 Shoreham Road that runs southwards from the High Trees roundabout junction, through the Adur valley to Shoreham is currently de-restricted.

A Community Highway Scheme is being introduced to improve pedestrian crossing facilities at various locations on Shoreham Road. There is an improved pedestrian refuge linking Dacre Gardens with the bus stop and with the footpath to the river and, another new pedestrian refuge where the South Downs Way crosses the A283.

It is proposed to reduce the speed limit to 40mph on the Shoreham Road from the High Trees roundabout junction southwards for a distance of 1040 metres. The reduced speed limit will improve safety for pedestrians using the new crossing locations and is desirable on the approaches to the roundabout. In addition, the reduced speed limit addresses safety concerns raised by the local community.

The Order is therefore proposed for avoiding danger to persons or traffic using the road of for preventing the likelihood of any such danger arising and for facilitating the safe passage on the road of any class of traffic including pedestrians.

**WEST SUSSEX COUNTY COUNCIL**  
**(UPPER BEEDING: A283 SHOREHAM ROAD & A2037)**  
**(40MPH SPEED LIMIT) ORDER 202\***

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the x day of x 202\* and may be cited as "West Sussex County Council (Upper Beeding: A283 Shoreham Road & A2037) (40mph Speed Limit) Order 2023"
2. The Order in the First Schedule to this Order is hereby revoked.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of road specified in the Second Schedule to this Order.
4. Nothing in Paragraph 3 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when –
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.

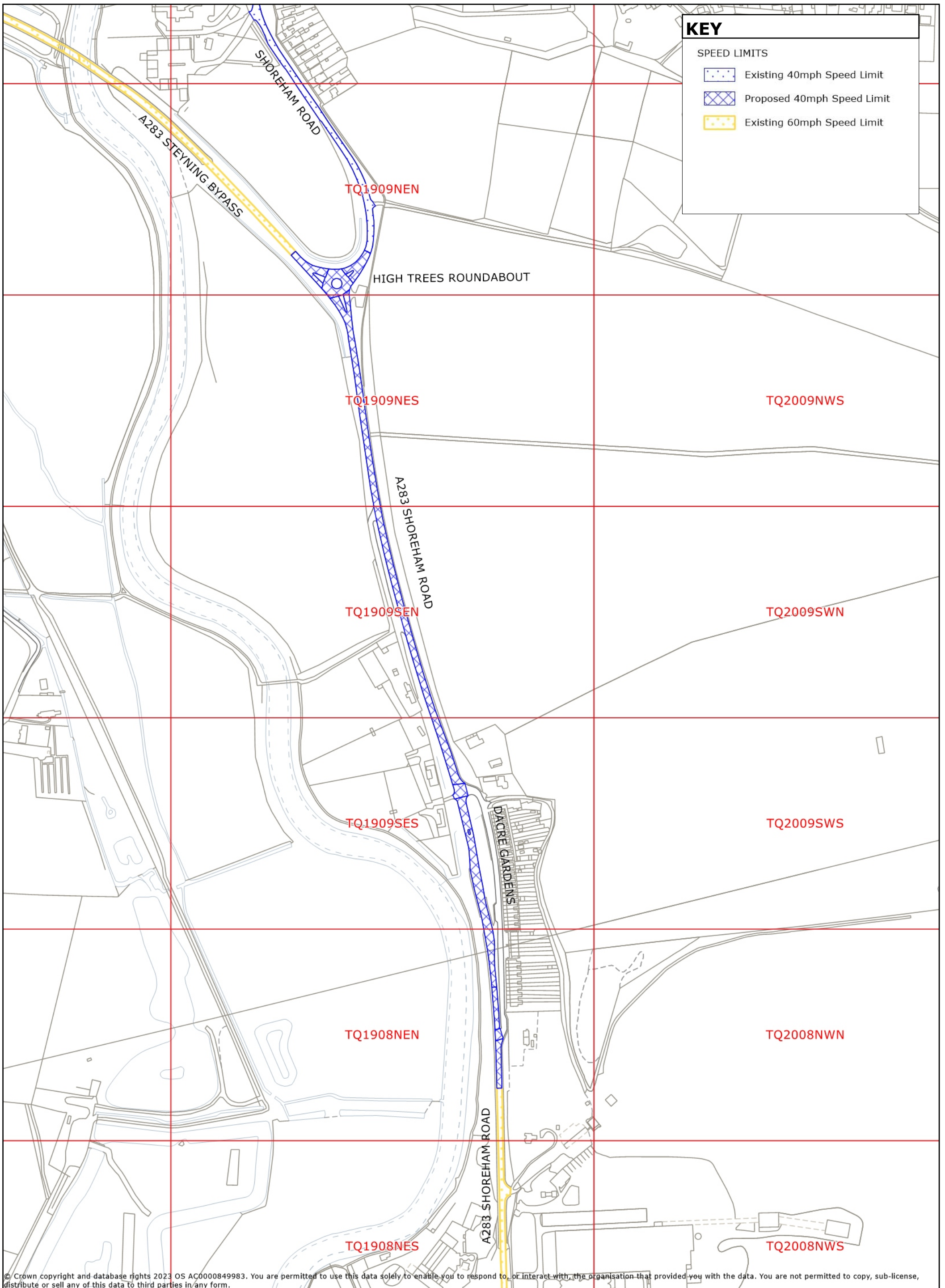
