NOTICE is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to reduce the 40mph speed limit across the Broadford Bridge junction to 30mph. The 30mph speed limit will apply to lengths of B2133 Adversane Lane, B2133 Harbolets Road, West Chiltington Lane and Broadford Bridge Road.

Statement Of Reasons For Proposing To Make The Order

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to reduce the speed limit across the Broadford Bridge junction to 30mph. The 30mph speed limit will apply to lengths of B2133 Adversane Lane, B2133 Harbolets Road, West Chiltington Lane and Broadford Bridge Road.

The roads across the Broadford Bridge junction are currently subject to a 40mph speed limit. The Council has received considerable anecdotal evidence from residents of numerous “near misses” and the residents association submitted a Community Highway Scheme application requesting that the speed limit to be reduced to 30mph

A Highway Improvements Scheme has been developed to fulfil that brief. It is proposed to reduce the 40mph speed limit to 30mph. This accords with the West Sussex County Council speed limit policy that sets local speed limits based on hierarchal and risk to safety needs. A 30mph speed limit is deemed appropriate at this location given the issues both with forward visibility of the junctions and for drivers exiting the side roads.

To encourage compliance with the new speed limit it will be supported by engineering measures including yellow backed signage, roundels and coloured high friction surfacing.

This Order is proposed so as to avoid danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising and for facilitating the safe passage of any class of traffic (including pedestrians).

Drawing HOR2308 West Chiltington - proposed speed limit (16.01.2024) shows the lengths of roads, which are the subject of the proposed order.

WEST SUSSEX COUNTY COUNCIL

(30MPH SPEED LIMIT) ORDER 202*

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the X Day of x 202* and may be cited as "West Sussex County Council (West Chiltington – Broadford Bridge: B2133 & Various Roads) (30mph Speed Limit) Order 202*"
2. The Order in the First Schedule to this Order is hereby revoked.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the lengths of roads specified in the Second Schedule to this Order.
4. Nothing in Paragraph 3 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when –
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.

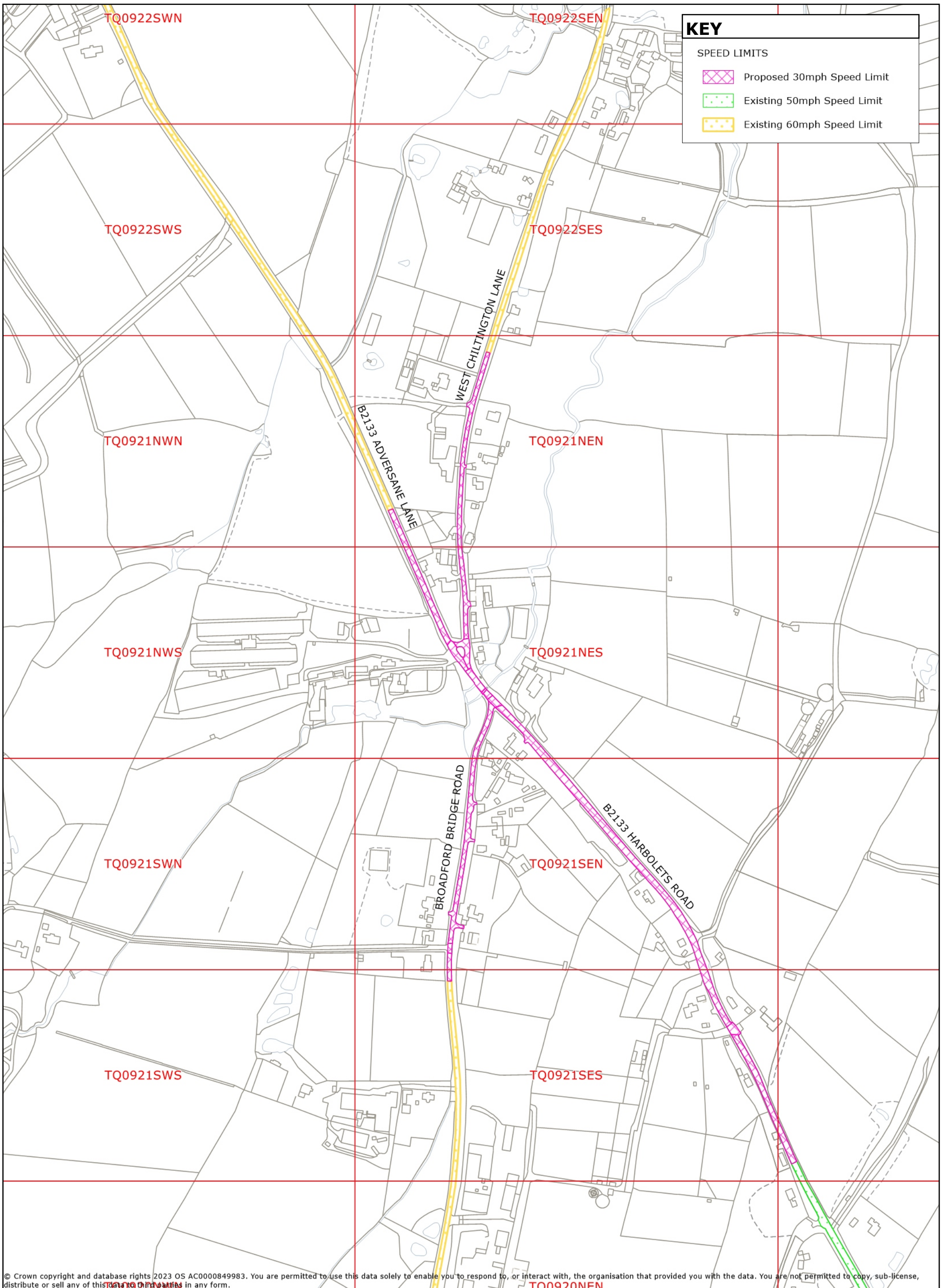
