STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to relocate the bus stop clearway on the north side of Swanfield Drive 8.3 metres south-west of its current position.

As part of the County Councils approach to bus service provision, highways infrastructure improvements are proposed to improve access to buses for passengers and to facilitate better bus movements on the highway. This site is included in the improvements programme.

It is proposed to introduce an uncontrolled crossing facility to support passenger movements across the highway. To accommodate this facility the existing bus stop cage is to be moved south-west. To ensure buses can manoeuvre in and out of the clearway a prohibition of wating restriction will be retained either side.

The Order is proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising and to facilitate the passage on the road of any class of traffic (including pedestrians).


