### (Littlehampton: River Road Amendment) Order 2022

NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (install double yellow lines) on the south-wester side of River Road in Littlehampton, at its junction with Wharf Road. The affected length of road is presently subject to a single yellow line restriction prohibiting waiting 8am to 6pm Mon-Fri.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the West Sussex County Council website. The <u>website</u> includes a response form for any comments or objections.

## (Littlehampton: River Road Amendment) Order 2022

### Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (install double yellow lines) on the south-wester side of River Road in Littlehampton, at its junction with Wharf Road. The affected length of road is presently subject to a single yellow line restriction prohibiting waiting 8am to 6pm Mon-Fri.

The new restriction is needed as part of a scheme to permit contraflow cycling on River Road between Terminus Place and Wharf Road. The new double yellow lines will prevent parking in a short length of marked cycle lane intended to provide safe access for northbound cyclists approaching the Arun footbridge.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to improve the amenities of the area through which the affected road runs.

The attached drawings, numbered TQ0202SWS shows the lengths of roads affected by the proposed order.


