STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce a 24 hour rural clearway on the A272 Hilland Road between the A29 Stane Street and A272 Coneyhurst Road.

Horsham District Council granted planning permission subject to a number of conditions for a mixed development on land to the east of Billingshurst. The development, known as Amblehurst Green includes 475 residential dwellings, a new primary school, dentists surgery and play space.

In accordance with the Section 106 planning obligations, a new 1.1km section of the A272 has been constructed linking the A29 Stane Street to the A272 Coneyhurst Road. The road is called Hilland Road.

As Hilland Road is the spine road it is proposed to introduce a 24 hour rural clearway along its entire length so that vehicles do not stop, park or wait on it at any time.

This Order is proposed for avoiding danger to persons or traffic using the road and to facilitate the passage on the road of any class of traffic and for facilitating the passage on the road of any class of vehicle (including pedestrians).
