## West Sussex County Council (Littlehampton: High Street) (Traffic Regulation) Order 2022

NOTICE is hereby given that West Sussex County Council proposes to make two permanent Traffic regulation Orders under the provisions of the Road Traffic Regulation Act 1984.

The effect of the first Order will be to introduce a formalised parking bay prohibiting waiting by any vehicle except taxis at any time on the north side of Terminus Road in Littlehampton, outside Littlehampton Station. It also prohibits waiting, loading and unloading at any time on both sides of Clifton Road, from its junction with Arcade Road to its junction with High Street, and prohibits waiting at any time, and loading/unloading between 9am and 5pm on High Street between Clifton Road and East Street.

The second Order prohibits driving on High Street from Clifton Road to East Street except for goods vehicles loading/unloading between 5pm and 9am the following morning.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the West Sussex County Council website. The <u>website</u> includes a response form for any comments or objections.

## West Sussex County Council (Littlehampton: High Street) (Traffic Regulation) Order 2022

# Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make two permanent Traffic Regulation Orders as follows:

The effect of the first Order will be to introduce a formalised parking bay prohibiting waiting by any vehicle except taxis at any time on the north side of Terminus Road in Littlehampton, outside Littlehampton Station. It also prohibits waiting, loading and unloading at any time on both sides of Clifton Road, from its junction with Arcade Road to its junction with High Street, and prohibits waiting at any time, and loading/unloading between 9am and 5pm on High Street between Clifton Road and East Street.

The second Order prohibits driving on High Street from Clifton Road to East Street except for goods vehicles loading/unloading between 5pm and 9am the following morning.

The second phase of the Littlehampton town centre regeneration scheme will improve footways on Terminus Road between the Town Centre and Littlehampton Railway Station. As this project was developed it was noted that the existing parking bay for taxis outside Littlehampton Railway Station was advisory and could not be enforced by local parking officers. The opportunity is therefore being taken to resolve this issue, which will ensure taxis are able to provide service to passengers at the station.

The Order also updates the parking map for Littlehampton to include the existing bus stops on Terminus Road between the junctions of Albert Road and Terminus Place. These bus stops are currently enforceable but are being added to the parking map for the area for housekeeping purposes.

The proposed Order for the first phase of the Littlehampton Regeneration scheme included a consolidation of the existing restriction which allows Goods vehicles to access the pedestrian area of High Street east of Clifton Road at any time. Following further consultation and review it has been requested that this area of High Street is kept free of vehicles in the daytime to improve pedestrian amenity, with access for loading provided at night-time only. It is proposed to enact this revised arrangement with a combination of new waiting restrictions and moving traffic restrictions to ensure access is available when needed and that adequate enforcement options are available if the new restrictions are not complied with.

The new orders are therefore proposed to preserve or improve the amenities of the area through which the road runs.

The attached drawing, numbered TQ0202SES shows the lengths of roads affected by the proposed parking order.

## WEST SUSSEX COUNTY COUNCIL (LITTLEHAMPTON: HIGH STREET) (TRAFFIC REGULATION)ORDER 2022

West Sussex County Council in exercise of their powers under Section 84 (1) a of the Road Traffic Regulation Act 1984 ("the Act"), and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

This Order shall come into operation on the \*\*\*\*\* day of \*\*\*\*\*\* and may be 1. cited as "West Sussex County Council (Littlehampton: High Street) (Traffic Regulation) Order 2022".

#### **Interpretation**

2. In this Order -

> "Goods Vehicle" means a motor vehicle or trailer constructed or adapted for use for the carriage or haulage of goods or burden of any description.

- 3. Save as provided by Article 4, no person shall cause or permit any vehicle other than a goods vehicle proceeding between the hours of 5pm to midnight and midnight to 9am for the purposes of loading or unloading, to proceed in the length of road specified in the Schedule to this Order.
- 4. Nothing in Article 3 shall apply to:
  - a) Any vehicle being used by the Police, Ambulance Service or Fire Brigade in the event of an emergency;
  - b) Any vehicle directed to proceed in the affected length of road by a Police Officer in uniform.


