Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting between 9am and 5pm Mon-Fri on the southern/western side of Willowhayne Crescent in East Preston, from a point 36m east of its junction with Sea Road to a point 4.5m south of its junction with Willowhayne Avenue.

East Preston Parish Council has agreed to fund a bus service serving East Preston, the route of which will include Willowhayne Crescent. The bus company operating the service has stated that due to the bend in the road and the presence of a large tree in the highway verge, parked vehicles on the inside of the bend would obstruct its buses. The restriction proposed is intended to allow the bus service to operate safely, while allowing parking at times the new service is not in operation.

The new order is therefore proposed to facilitate the passage of traffic and preserve or improve the amenities of the area through which the road runs.

The attached drawing, numbered TQ0701NWN shows the length of road affected by the proposed order.




