NOTICE is hereby given that West Sussex County Council proposes to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to make the following amendments to the existing parking/waiting restrictions in the Horsham Controlled Parking Zone:

- (i) Introduce a no waiting, loading and unloading restriction on lengths of Carfax, and
- (ii) introduce a no waiting at any time restriction (double yellow lines) on lengths of Causeway, London Road, Tanbridge Park and Worthing Road (bus station), and
- (iii) introduce a Goods Vehicles loading bay at any time in Carfax, and
- (iv) extend the hours on the permit holders bays in Carfax, and
- (v) provide additional permits holders bays in Depot Road Service Road and Milnwood Road; and
- (vi) formalise disabled bays at any time in Carfax, Lower Tanbridge Way, New Street and West Parade.

The consultation for this proposal will start on 18 May 2023 and, AT THAT TIME, full details of the proposals in this Notice can be viewed on the TRO pages of the [West Sussex County Council website](#). The website includes a response form for comments or objections.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to make the following amendments to the existing parking/waiting restrictions in the Horsham Controlled Parking Zone:

- (i) Introduce a no waiting, loading and unloading restriction on lengths of Carfax, and
- (ii) introduce no waiting at any time restriction (double yellow lines) on lengths of Causeway, London Road, Tanbridge Park and Worthing Road (bus station), and
- (iii) introduce a Goods Vehicles loading bay at any time in Carfax, and
- (iv) extend the hours on the permit holders bays in Carfax, and
- (v) provide additional permits holders bays in Depot Road Service Road and Milnwood Road; and
- (vi) formalise disabled bays at any time in Carfax, Lower Tanbridge Way, New Street and West Parade.

As part of the on-going maintenance of the CPZ in Horsham the parking and waiting restrictions are kept under review. Following a previous consultation it was agreed to undertake a wider engagement exercise with residents about extending the hours of enforcement in existing zones and extending the zones to include other roads.

Following completion of that exercise it has been agreed that neither the zones nor the enforcement hours of the zones will change at this time. Instead a number of minor localised amendments are proposed in roads across the CPZ to improve access to parking bays and loading facilities and to improve the on-street parking capacity for both residents and visitors.

This Order is proposed for facilitating the passage on the road of any class of traffic and for preserving the amenity of the area through which the roads run.
