STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on both sides of The Hordens south of the junction with Two Mile Ash Road.

A Community Highway Scheme is being progressed to improve the walking facilities to and from Barns Green School. The uncontrolled crossing point at The Hordens is being upgraded to provide a safe walking route with good visibility. The improved crossing point will include dropped kerbs and tactile paving.

It is proposed to introduce double yellow lines to prohibit parking in close proximity to the crossing point and the junction with Two Mile Ash Road to maintain intervisibility between road users.

This Order is proposed for avoiding danger to persons or traffic using the road and to facilitate the passage on the road of any class of traffic and for facilitating the passage on the road of any class of vehicle (including pedestrians).


