NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) at the junctions of Chichester Road with New Barn Lane and Brazwick Avenue. The proposed new lines at the Brazwick Avenue junction are extended along the frontage of the fuel filling station.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

(Bersted: Chichester Road and Adjoining Roads Amendment) Order 2023 Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) at the junctions of Chichester Road with New Barn Lane and Brazwick Avenue. The proposed new lines at the Brazwick Avenue junction are extended along the frontage of the fuel filling station.

Local residents have submitted an application for new parking restrictions at the junctions of Chichester Road with New Barn Lane and Brazwick Avenue. It is reported that vehicles are frequently parked on both sides of New Barn Lane near its junction with Chichester Road, leaving no room for vehicles travelling in opposite directions to pass each other. This can result in vehicles being unable to enter New Barn Lane from Chichester Road, which in turn leads to queueing traffic on Chichester Road.

At Brazwick Avenue it is reported that vehicles frequently park close to the junction with Chichester Road to access to the shop at the service station. This obstructs the vision of vehicles passing through the junction and obstructs the flow of traffic.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered SU9101SES shows the lengths of roads affected by the proposed order.


