Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) on both sides of Drygrounds Lane in Felpham, from the western end of the road, eastwards for 50m.

Drygrounds Lane is a no-through road regularly used as an area to pick up/drop off students at Felpham Community College. At the beginning and end of the school day, high numbers of parked vehicles at the western end of the road prevent other vehicles turning in the road to leave Drygrounds Lane. It is reported that this leads to drivers carrying out dangerous manoeuvres while attempting to leave the road while high numbers of pupils are passing through the area on foot. The volume of parking also obstructs access for residents.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic

The attached drawing, numbered SU9400SES shows the lengths of roads affected by the proposed order.




