Statement Of Reasons For Proposing To Make The Order

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce a 40mph speed limit on the length of the A283 through Wiggonholt between Marehill and Cootham and, on Church Lane.

The A283 links the villages of Storrington and Pulborough. The section between the more built-up areas of the villages is currently de-restricted and as a result has become a well used cut through route and motorcycle circuit. Concerns of residents about road safety have been expressed by the Parish Council. This section of road runs alongside the RSPB Pulborough Brooks reserve and local wildlife groups and residents have also raised concerns about noise pollution.

The West Sussex Speed Limit Policy states that assessing a road for an appropriate speed limit in West Sussex includes taking the following into account:

- Functional hierarchy of the route
- The length of the route to be subject to the speed limit
- Road Traffic Collision history
- Traffic speeds (speed assessment)
- Other means of intervention to improve road safety.

The application has been assessed in line with the above policy. This route is heavily used and due to the nature of the road layout, the speed limit is often exceeded. There have been 3 speed related serious accidents and 4 slight incidents in the last 3 years. A 40mph speed limit is considered appropriate in this location.

To encourage compliance with the 40mph speed limit, in addition to the 40mph terminal signs the speed limit will be supplemented by 11 repeater signs. The introduction of the reduced speed limit and additional measures aims to bring the vehicle speeds down to the proposed signed limit.

This Order is proposed for avoiding danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising and for facilitating the safe passage on the road of any class of traffic (including pedestrians), for preserving or improving the amenity of the area through which the road runs and for preserving the character of the road.

WEST SUSSEX COUNTY COUNCIL (STORRINGTON & SULLINGTON, PULBOROUGH & PARHAM: A283 & CHURCH LANE) (40MPH SPEED LIMIT) ORDER 2023

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the x day of x 2023 and may be cited as "West Sussex County Council (Storrington & Sullington, Pulborough & Parham: A283 & Church Lane) (40mph Speed Limit) Order 2023"
- 2. The Orders specified in the First Schedule to this Order is hereby revoked.
- 3. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the lengths of roads specified in the Second Schedule to this Order.
- 4. Nothing in Paragraph 3 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.
