NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on both sides of Broadstrand, from the parking layby on the southern side of the road, westwards to its junction with Mariners Walk. This restriction also extends a short distance into Mariners Walk to prevent parking on the bend in the road.

The Order also prohibits waiting at any time on the eastern side of Mariners Walk in Rustington at the entrance to the garage compound at the southern end of the road.

Full details of the proposals in this notice can be viewed on the Traffic Regulation Order page of the <u>West Sussex County Council website</u>. The website includes a response form for any comments or objections.

(Rustington: Mariners Walk & Broadstrand Amendment) Order 2023 Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) on both sides of Broadstrand, from the parking layby on the southern side of the road, westwards to its junction with Mariners Walk. This restriction also extends a short distance into Mariners Walk to prevent parking on the bend in the road.

The Order also prohibits waiting at any time on the eastern side of Mariners Walk in Rustington at the entrance to the garage compound at the southern end of the road.

Local residents have submitted an application for parking restrictions at the junction between Mariners Walk and Broadstrand due to persistent parking on the bend, which unacceptably restricts the vision of traffic passing through the bend, creating a hazard.

It is also reported that vehicles frequently park too close to the entrance to the garage compound behind Broadstrand, preventing those exiting the compound from seeing approaching traffic.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawings, numbered TQ0501NES and TQ0501SEN show the lengths of roads affected by the proposed order.








