NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on the eastern side of Sea Road in East Preston from its northern junction with the Sea Road Service Road, to its southern junction with Sea Road Service Road.

The Order also prohibits waiting at any time on the western side of North Lane from its junction with Lashmar Road, southwards to the existing 'School Keep Clear' marking.

(East Preston: Sea Road and North Lane Amendment) Order 2023

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce double yellow lines on the eastern side of Sea Road in East Preston from its northern junction with the Sea Road Service Road, to its southern junction with Sea Road Service Road.

The Order also introduces double yellow lines on the western side of North Lane from its junction with Lashmar Road, southwards to the existing 'School Keep Clear' marking.

West Sussex County Council has received a community application for waiting restrictions at the above locations. It is reported that vehicles parking on Sea Road near the shops create a bottleneck which obstruct the passage of large vehicles, especially buses operating the new bus route to East Preston. The new restrictions will prevent this obstruction while leaving the availability of parking in the Sea Lane Service Road unaffected.

The restrictions proposed on North Lane, near its junction with Lashmar Road are proposed in response concerns that vehicles parking at this location obstruct visibility at the junction and create a pinch point on North Lane where visibility is already restricted by a bend in the road. This location is a on a busy route to school and extending the restriction is considered necessary to maintain safety at the junction.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered TQ0702SWN shows the lengths of roads affected by the proposed order.


