NOTICE is hereby given that West Sussex County Council, under the provisions of the Highways Act 1980 (Traffic calming) Regulations intends to install raised traffic calming features on Firs Avenue in Felpham.

The features would be comprised of five pairs of raised 'speed cushions' located approximately outside no.s 2, 10, 15, 31 and 38 Firs Avenue. Each speed cushion will be 1.6m wide 3m long and appx 66mm high and constructed in black macadam.


Statement of Reasons for Proposing Traffic Calming Features


West Sussex County Council proposes to install five pairs of traffic calming speed cushions on Firs Avenue in Felpham, located approximately outside no.s 2, 10, 15, 31 and 38 Firs Avenue. Each speed cushion will be 1.6m wide 3m long and appx 66mm high and constructed in black macadam.

Concerns have been raised that the 20 MPH Speed limit on Firs Avenue is regularly contravened by drivers. The proposed measures are intended to improve compliance with the speed limit, improving safety on the road. As part of the project it is also proposed to improve speed limit signage and road markings in the road.
