## **Key Responsibilities**

Working with Members and key partners, lead the development of the Council's strategy for a sustainable environment, defining the ways in which outcomes will be achieved and success measured in support of the objectives and values of the Council.

Determine the vision and strategy for waste management, including through collaboration with partners, and represent and promote the waste strategy at local, regional and national levels.

Provide strong, visible strategic leadership to the services in the directorate ensuring contribution to agreed strategy and environmental agenda and compliance with all relevant legislation and statutory requirements within an acceptable level of risk.

Lead the procurement and contracting for the directorate, ensuring they deliver intended outcomes which represent long-term value for money at an acceptable level of risk.

Accountable for Waste Service contracts commercial management and monitoring (currently valued at £60m per annum), ensuring effective performance management to achieve value for money and manage risks and liabilities.

Provide guidance and support to Cabinet and members in translating their waste, environmental and energy political objectives and priorities into coherent initiatives that will deliver their intended outcomes for West Sussex. Provide professional advice to senior officers and elected members on all matters of Waste strategy and policy.





Manage the relationships for the Council with external organisations, ensuring the delivery of effective outcomes through collaborative working. Develop strong relationships with district and borough council partners in formulating environmental strategy and in managing services which contribute to desired outcomes. Provide leadership for work to negotiate any changes in waste contractual responsibilities and contracts. Develop constructive relationships and partnerships with a range of stakeholders including business, government agencies, community, local authorities and community planning partners at locally, nationally and international level.

Accountable for significant delegated financial budgets and resources ensuring they are managed effectively for delivery of intended outcomes in a value for money and compliant approach.

Lead the planning and design for a defined range of services to support the commissioning and delivery of the best possible outcomes for the citizens and communities of West Sussex. Develop business plans to implement the agreed business strategies for the Council and its partners which are focused on delivering the political objectives and priorities of West Sussex and mitigate all identified risks.

Direct and be directly accountable for service performance and contributing to the performance management of other Council and partners' services which contribute. Using strategic performance indicators to measure success.

Provide strategic leadership for the Council's corporate approach to the environmental agenda for West Sussex providing professional leadership in environmental strategy and management. Representing and advocating the Council's perspective on the matter to national and regional bodies ensuring the Council's approach is coherent and well-articulated.

As the lead director for trading standards, you will ensure the County Council discharges its obligations in relation to the prevention of crime and disorder and associated responsibilities in accordance with the Crime and Disorder Act 1998 and be responsible for county council responsibilities in relation to associated statutes including in relation to licensing, enforcement powers (jointly with the Director of Law and Assurance), approval of fees chargeable, and the appointment of officers under the Food Safety Act 1990, the Weights and Measures Act 1985, and the Agriculture Act 1970.
