PUBLIC INQUIRIES TO BE HELD AS A VIRTUAL EVENT

NOTICE is hereby given that Public Local Inquiries in connection with the Orders mentioned below, will be held by an Inspector appointed for this purpose by the Secretary of State for Transport, and will **begin at 10.00am on Tuesday 10 August 2021**. The Inquiries will be held as a virtual event, run by an Inspector in the normal way but with the parties invited to join via Microsoft Teams or telephone.

NOTICE is hereby given that a Pre-Inquiries Meeting will be held as a virtual event **beginning at 10.00 am on Wednesday 2 June 2021** where the Inspector will arrange the timetable for the proceedings in connection with the Orders named below. The right to make representations at the Public Local Inquiries will in no way be prejudiced by the inability to attend or be represented at the Pre-Inquiries Meeting.

The Inquiries are being held to hear representations about the Orders from remaining objectors (as defined in the Compulsory Purchase (Inquiries Procedure) Rules 2007) and statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1994), from any other persons having an interest in the land the subject of the Compulsory Purchase Order and, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

The Orders have been made by West Sussex County Council under the above-mentioned Acts and submitted to the Secretary of State for Transport for confirmation and are:

(1) THE WEST SUSSEX COUNTY COUNCIL (A284 LYMINSTER BYPASS (NORTH) CLASSIFIED ROAD) (SIDE ROADS) ORDER 2020. This is an Order under Sections 14 and 125 of the Highways Act 1980.

(2) THE WEST SUSSEX COUNTY COUNCIL (A284 LYMINSTER BYPASS (NORTH)) COMPULSORY PURCHASE ORDER 2020. This is an Order under Sections 239, 240, 246, 250 of the Highways Act 1980.

THE ORDERS relate to proposals known as the A284 Lyminster Bypass which is the improvement and realignment of the existing A284 Lyminster Road from a point approximately 600m south of the A27 Crossbush junction southwards for approximately 303 metres and a newly constructed length of bypass that will extend from this point south to meet the A284 Lyminster Bypass (South) which is being constructed as part of the mixed use North Littlehampton development in the Parishes of Lyminster and Crossbush and Littlehampton in the District of Arun in the county of West Sussex.

PROCEEDINGS on the above-mentioned Orders are being taken concurrently by virtue of Section 257 of the Highways Act 1980.
