#### STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at any time (double yellow lines) on both sides of Prinsted Lane either side of and opposite the junction with Frarydene

Southbourne Parish Council supported by local residents made representations to the County Council that parking on Prinsted Lane at its junction with Frarydene causes obstruction and presents a hazard to road users.

Prinsted Lane is a residential road providing a route to parking areas close to the sea, consequently there can be periods of high demand. Parking on-street in close proximity to the junction with Frarydene causes localised access difficulties.

It is proposed to introduce lengths of prohibition of waiting at any time (double yellow lines) on both sides of Prinsted Lane at and opposite the junction with Frarydene.

These waiting restrictions aim to better manage parking by prohibiting parking in those locations where parked vehicles cause obstruction.

The Order is proposed to avoid danger to persons or other traffic using the roads o for preventing the likelihood of any such danger arising, to facilitate the passage on the road of any class of traffic and to preserve or improve the amenity of the area through which the road runs.


