STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of Langley Lane at its junction with Ifield Green.

Langley Lane is a privately owned road which adjoins the public highway of Ifield Green. Langley Lane serves as an access road to the nearby Langley Corner medical centre.

The County Council received an application requesting the reintroduction of parking restrictions on the junction of Langley Lane and Ifield Green. Representation from the local community expressed concern about the level of parking in the area. Unrestricted parking on the junction of Langley Lane with Ifield Green and at the access to the medical centre, restricts visibility for vehicles both exiting and approaching the junction and the medical centre and, can cause difficulties for emergency vehicles.

A TRO to resolve this issue has been prioritised for progression as part of the Councils works programme.

The introduction of lengths of double yellow lines on Langley Lane aims to deter inconsiderate on-street parking to alleviate localised obstruction and access difficulties.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians).


