**Statement Of Reasons For Proposing To Make The Order**

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to extend the existing 40mph speed limit on the B2166 Pagham, North Mundham eastwards for a distance of 1.12km through Oving Parish and into Pagham Parish

The B2166 Pagham Road is a semi-rural road approaching the village of Runcton from the south. There is some roadside development with accesses serving several residential properties and businesses, including a garden centre.

North Mundham Parish Council applied for a Traffic Regulation Order (TRO) to introduce a new 40mph speed limit order, extending the current 40mph speed limit to the Oving Parish boundary.

A review of the speed limit has been carried out and the proposed 40mph maximum limit is compliant with the County Council's Policy and more adequately reflects the character of these roads. The primary aim of the initiative is of road safety and casualty prevention, and it is intended that this approach will not compromise the effectiveness of existing speed limits around the County.

There is a double bend on the B2166 immediately beyond the requested extent of the 40mph speed limit. There have been 3 serious injury collisions recorded at this location in the latest 5-year period for which data is available, including one within the last 3 years. It is therefore proposed that the 40mph speed limit be extended by an additional 400m, so that it includes this double bend, for safety reasons.

This Order is proposed so as to reduce danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising, for facilitating the safe passage on the road of any class of traffic and for preserving or improving the amenities of the area through which the road runs.

Drawing North Mundham, Oving, Pagham: B2166 Pagham Road Proposed 40mph Speed Limit (22.11.22) shows the length of road, which is the subject of the proposed Order.

**WEST SUSSEX COUNTY COUNCIL**

**(40MPH SPEED LIMIT) ORDER 2022**

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the x day of x 2022 and may be cited as "West Sussex County Council (North Mundham, Oving and Pagham:B2166 Pagham Road) (40mph Speed Limit) Order 2022"
2. The parts of the Order in the First Schedule to this Order are hereby revoked
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of road specified in the Second Schedule to this Order.
4. Nothing in Paragraph 3 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown on an occasion when –
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.

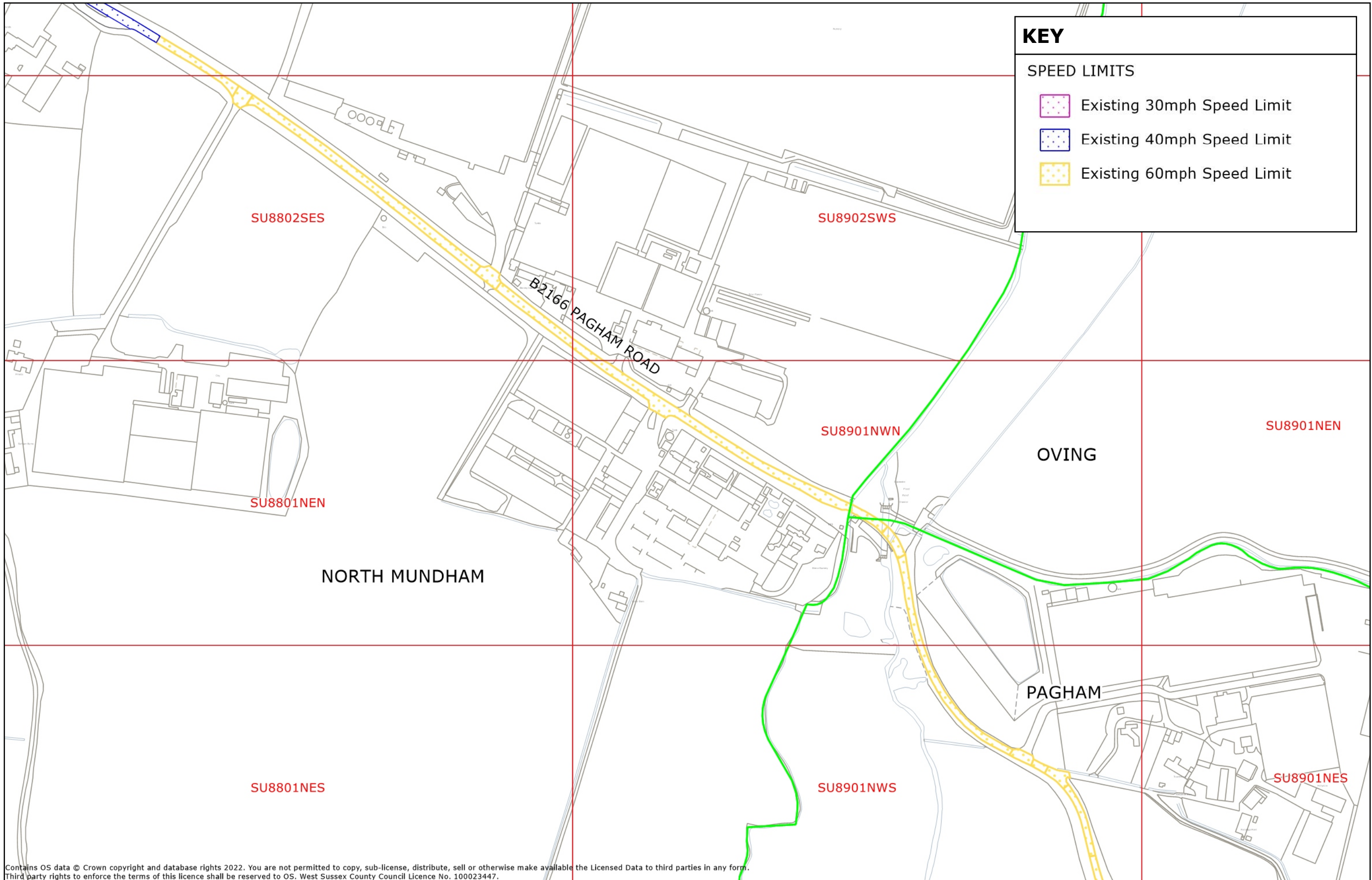

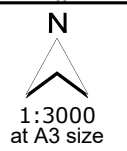


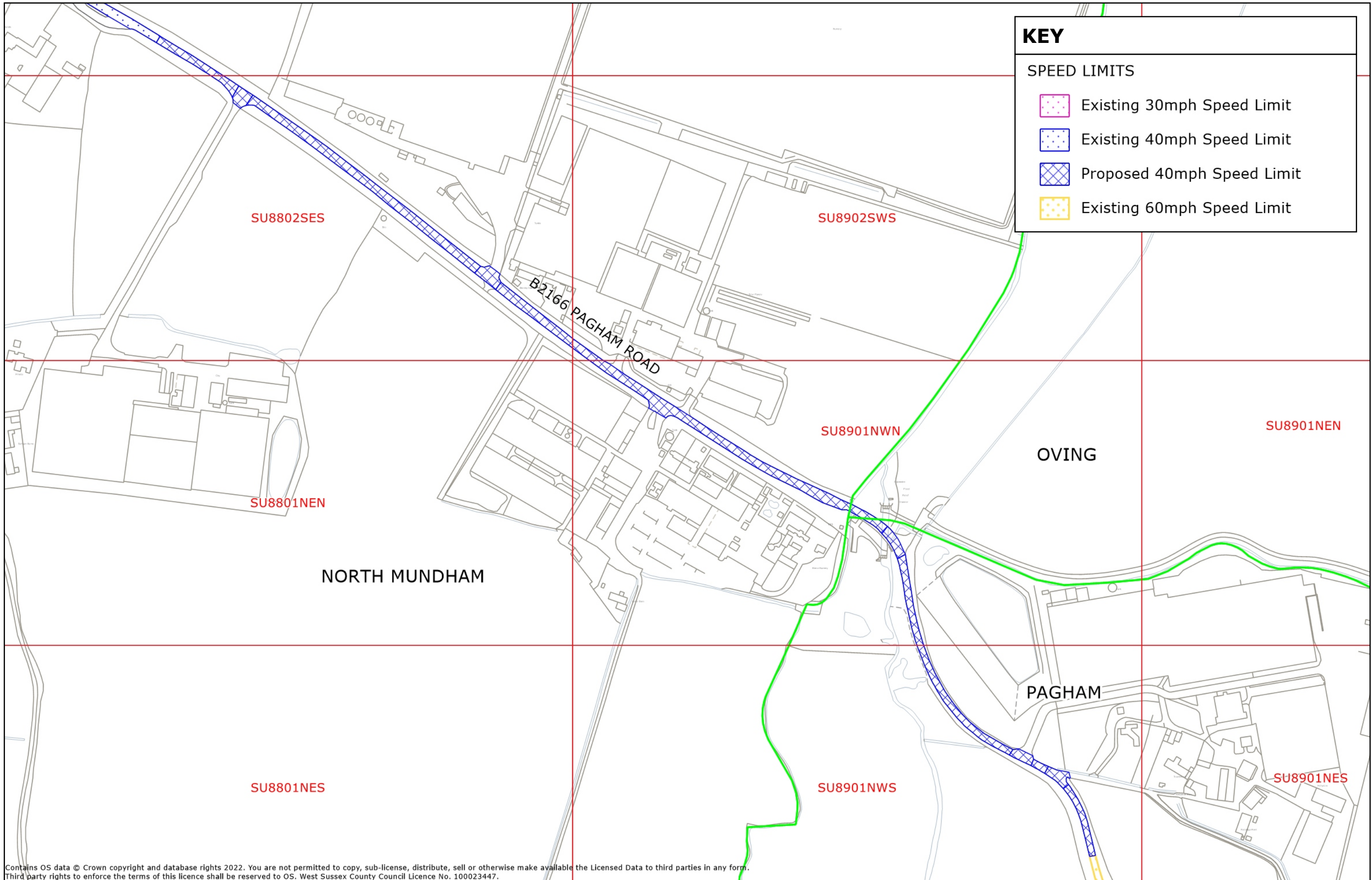
