STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to extend the School Keep Clear prohibiting stopping at any time on both sides of Chidham Lane across the entire frontage of Chidham Parochial Primary School.

The footway on Chidham Lane adjacent to Chidham Parochial Primary School is very narrow. There is also a layby on the eastern side. Once cars have dropped off passengers in the layby they frequently perform turning manoeuvres which result in the rear of the vehicles overhanging the already narrow footway.

An approved Community Highway Scheme proposes to close the layby and widen the footway. Currently the School Keep Clear marking only covers a section of the school frontage. As part of the Community Highway Scheme it is proposed to extend the School Keep Clear marking to cover the entire school frontage to protect school children and other pedestrians using the footway.

The Order is proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising, to facilitate the passage on the road of any class of traffic (including pedestrians).




