NOTICE is hereby given that West Sussex County Council proposes to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to make the following amendments to the existing parking/waiting restrictions in the Chichester City Centre:

- (i) Introduce a no waiting, loading and unloading restriction on lengths of Cutten Way, The Hornet, Service Area NE4 between North Street and St Martins Square, and
- (ii) formalise the no waiting, loading and unloading restriction on the pedestrianised sections of East Street and North Street, and
- (iii) extend/introduce no waiting at any time restriction (double yellow lines) on lengths of Cambrai Avenue, Florence Road, Graylingwell Drive, Green Lane, Highland Road, Infirmary Terrace, Little London, Oliver Whitby Road, Ormonde Avenue, St Pancras, Somerstown, Swanfield Drive, Waterside Drive and Windsor Road, and
- (iv) introduce single yellow lines on lengths of Little London and Cavendish Street, and
- (v) provide additional residents only parking bays in Alexandra Road, Lewis Road, Somerstown and West Street, and
- (vi) provide additional shared use bays in St Martins Square and Stockbridge Road; and
- (vii) extend controls in CPZ Zone J Franklin Place to include Sundays, and
- (viii) extend the hours on the designated Doctors Vehicles bays in Parklands Road; and
- (ix) formalise disabled bays at any time in Adelaide Road, Bradshaw Road, Cooper Street, Kingsham Road, Lewis Road, Melbourne Road, Oving Road, Service Area NE4 between North Street and St Martins Square, Somerstown, Spitalfield Lane and Cavendish Street.

The consultation for this proposal will start on 13 April 2023 and, AT THAT TIME, full details of the proposals in this Notice can be viewed on the TRO pages of the <u>West Sussex County Council website</u>. The website includes a response form for comments or objections.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to make the following amendments to the existing parking/waiting restrictions in the Chichester City Centre:

- (i) Introduce a no waiting, loading and unloading restriction on lengths of Cutten Way, The Hornet, Service Area NE4 between North Street and St Martins Square, and
- (ii) formalise the no waiting, loading and unloading restriction on the pedestrianised sections of East Street and North Street, and
- (iii) extend/introduce no waiting at any time restriction (double yellow lines) on lengths of Cambrai Avenue, Florence Road, Graylingwell Drive, Green Lane, Highland Road, Infirmary Terrace, Little London, Oliver Whitby Road, Ormonde Avenue, St Pancras, Somerstown, Swanfield Drive, Waterside Drive and Windsor Road, and
- (iv) introduce single yellow lines on lengths of Little London and Cavendish Street, and
- (v) provide additional residents only parking bays in Alexandra Road, Lewis Road, Somerstown and West Street, and
- (vi) provide additional shared use bays in St Martins Square and Stockbridge Road; and
- (vii) extend controls in CPZ Zone J Franklin Place to include Sundays, and
- (viii) extend the hours on the designated Doctors Vehicles bays in Parklands Road; and
- (ix) formalise disabled bays at any time in Adelaide Road, Bradshaw Road, Cooper Street, Kingsham Road, Lewis Road, Melbourne Road, Oving Road, Service Area NE4 between North Street and St Martins Square, Somerstown, Spitalfield Lane and Cavendish Street.

In 2015 Chichester was selected as the pilot study for the countywide road space audit programme. The aim was to future proof parking controls and to pre-empt the impact of displaced parking following incremental extensions of parking controls.

Following subsequent public consultation and engagement exercises it was agreed to proceed with the parking management plan element of the road space audit in Phases with a minor amendment to existing parking controls introduced as part of Phase 1 in 2021.

Further consultation has been undertaken to evaluate the implemented measures and there is significant support for amendments in Zone J and to include Cutten Way in the CPZ.

In addition multiple minor amendments are proposed in roads across the City to improve safety, access and visibility and to increase the on-street parking capacity for both residents and visitors.

The opportunity is being taken to make minor corrective amendments to Order Schedules

This Order is proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising, to improve the amenity of the area through which the roads run and to facilitate the passage of traffic.
