Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time at the junction of Fairfield Road with Toll Gate in Burgess Hill.

Toll Gate is a cul-de-sac on the southern side of the bend in Fairfield Road. Residents have raised concerns that vehicles frequently park very close to the junction, which combined with the bend, makes it extremely difficult for road users emerging from Toll Gate to see vehicles approaching on Fairfield Road. This makes the junction hazardous.

To resolve this problem a short length of double yellow line is proposed on the southern side of Fairfield Road, either side of its junction with Toll Gate. The length of line proposed has been kept to a minimum to improve visibility while retaining as much parking as possible on Fairfield Road.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

Prevent damage to the road or other buildings near the road and to facilitate the passage of traffic.

The attached drawing, numbered TQ3019NEN shows the length of road affected by the proposed order.




