### (East Grinstead: Blackwell Farm Road and Elizabeth Crescent Amendment) Order 2023

#### **Statement of Reasons for Proposing to Make the Order**

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce various short lengths of new double yellow lines near the traffic island at the northern junction of Blackwell Farm Road with Elizabeth Crescent in East Grinstead.

The northern junction of Elizabeth Crescent with Blackwell Road is opposite Blackwell Primary School and is split by a large traffic island. It is reported that particularly at school pick up and drop off times, vehicles are parked on the traffic island, causing damage to the verge, obstructing traffic at the junction and making the junction hazardous for pedestrians.

It is proposed to resolve these problems by installing bollards to prevent parking on the traffic island. As part of this scheme, it is proposed to revise the existing double yellow line markings at the junction, making short extensions to existing lines where necessary to improve safety near the junction, and to provide safe crossing points for pedestrians by creating a break between parked cars.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered TQ3939SES shows the lengths of roads affected by the proposed order.


