#### (East Grinstead: Lingfield Road Amendment) Order 2023

#### Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will extend an existing length of double yellow line on the eastern side of Lingfield Road in East Grinstead so that it runs from the junction with Durkins Road northwards for a distance of approximately 20m.

It is proposed to install a new buildout on the footway of Lingfield Road, immediately north of the junction of Durkins Road. This will act as a crossing point for pedestrians accessing the recreation ground on the western side of the road, improving safety by providing an improved view of approaching traffic. The installation of this new buildout requires a short extension of the existing double yellow lines at this location to ensure the new feature is not obstructed by parked vehicles.

The new order is therefore proposed to avoid danger to persons using the affected length of road and to improve the amenities of the area through which the road runs.

The attached drawing, numbered TQ839SES shows the length of road affected by the proposed order. Drawing number 7009567 shows the layout of the proposed buildout feature.


