STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce a bus stop clearway and a length of prohibition of waiting at any time (double yellow lines) on the north side of Spitalfield Lane between Swanfield Drive and Lime Close.

As part of the County Councils approach to improvements to bus service provision, highways infrastructure improvements are proposed to facilitate the new Stagecoach route 500 bus service connecting Chichester and Littlehampton.

Highways works have been progressed along the new bus route to formalise existing bus stops. In Spitalfield Lane a new bus stop clearway is required to allow passengers to alight safety adjacent to the kerbline and onto the footway. In addition to the bus stop clearway a length of double yellow lines is proposed to protect access for buses using the bus stop.

The Order is proposed to avoid danger to persons or other traffic using the roads or for preventing the likelihood of any such danger arising and to facilitate the passage on the road of any class of traffic (including pedestrians).






PAGE 1 OF 2: EXISTING RESTRICTIONS ONLY
