STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of Church Road west of St Michael and All Angels Church

Church Road is a residential cul-de-sac located in the Lowfield Heath Industrial Estate area and in close proximity to Gatwick Airport.

Local residents and businesses have expressed concerns about the level of parking in the area. The current on-street parking causes localised obstruction and access difficulties for business deliveries. Unrestricted parking close to business accesses restricts visibility for vehicles exiting and entering the commercial premises.

To alleviate the problem, it is proposed to prohibit parking with extended lengths of double yellow lines. The aim is to ensure drivers and pedestrians have more forward visibility to pass safely and aid traffic movements, and to deter obstructive parking practice.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and to preserve or improve the amenities of the area through which the road runs.

Plan Nos. TQ2740SES & TQ2740SWS show the length of road, which is the subject of the proposed Order.






