NOTICE is hereby given that in exercise of their powers under the Road Traffic Regulation Act 1984, West Sussex County Council, propose to make a permanent Order the effect of which will be to extend the existing bus stop clearway on the north side of Loxwood Road adjacent to Plaistow & Kirdford Primary School and to extend the operative hours to apply 7am to 7pm daily.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to extend the existing bus stop clearway on the north side of Loxwood Road adjacent to Plaistow & Kirdford Primary School and to extend the operative hours to apply 7am to 7pm daily.

There is inadequate road space for the buses to drop off and pick up pupils outside the Plaistow & Kirdford Primary School. With no alternative place to stop buses have on occasion stopped on School Keep Clear markings and in doing so contravene the provisions of the Traffic Regulation Order.

The Parish Council have contacted the School Transport Team seeking a better solution to enable children to be dropped off outside the school.

Providing a place for buses to stop to drop off and collect children safely from school supports the Councils core priorities for educational attainment for the best start in life, whilst also supporting provision of more sustainable forms of transport.

It has been agreed that the appropriate course of action is to replace the School Keep Clear markings on Loxwood Road with a bus clearway of adequate size to accommodate 2 buses.

The Order is proposed to facilitate the passage on the road of any class of traffic (including pedestrians) and to preserve or improve the amenities of the area through which the road runs.
