STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of the east-west section of Reynolds Place, south-east of the junction with Reynolds Road.

Reynolds Place is a 'D' class residential cul-de-sac. The road has a narrow width and provides access to businesses, local shops, garages and properties. Currently on-street parking causes localised obstruction and access difficulties and there are frequently reported incidences where business deliveries are blocked by parked vehicles.

To alleviate the problem, it is proposed to introduce lengths of prohibition of waiting at all times (double yellow lines) on the narrower section of Reynolds Place from the junction with Reynolds Road. This aims to deter parking, improve forward visibility and aid safe passage of both drivers and pedestrians.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising, for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenities of the area through which the road runs.


