**NOTICE** is hereby given that West Sussex County Council has made an experimental Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit driving (except for access to/from residential addresses) between 8am to 9am and 2.30pm to 3.30pm Mon-Fri throughout all lengths of Glebeside Avenue and Glebeside Road in Worthing.

**WEST SUSSEX COUNTY COUNCIL**  
**(WORTHING: GLEBESIDE AVENUE & GLEBESIDE CLOSE)**  
**(EXPERIMENTAL PROHIBITION OF DRIVING) ORDER 2023**

West Sussex County Council in exercise of their powers under Sections 9 and 10 (2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the Seventh day of September 2023 and may be cited as "West Sussex County Council (Worthing: Glebeside Avenue & Glebeside Close) (Experimental Prohibition of Driving) Order 2023"
2. In this Order:-  
  
"motor vehicle" has the meaning assigned to it in section 136(1) of the Act.
3. Save as provided in Article 4, no person shall cause or permit any motor vehicle to proceed in the length of road specified in the Schedule to this Order during the periods of 0800 to 0900, and 1430 to 1530 Monday to Friday.
4. Nothing in Article 3 shall apply to:
  - a. A vehicle being used by the Police, Fire Brigade or Ambulance Service in the event of an emergency; or
  - b. A vehicle being driven under the direction of a police officer in uniform; or
  - c. A vehicle being driven for the purpose of gaining access to a residential address located within the length of road specified in the Schedule to this Order; or
  - d. A vehicle being driven by an employee of a school located within the length of road specified in the Schedule to this Order for the purpose of gaining access to, or exiting from the school; or
  - e. A vehicle being driven for the purpose of gaining access to or exiting from any business operating from premises located within the length of road specified in the Schedule to this Order; or
  - f. A vehicle located within the length of road specified in the Schedule to this Order before the commencement time periods in Article 3, being driven so as to leave the affected length of road; or
  - g. A bus being driven in the course of operating a local service; or
  - h. A motor vehicle being used in the course of providing school transport authorised by West Sussex County Council; or
  - i. A motor vehicle displaying a valid disabled persons' blue badge.




