Consolidation) Order 2023

NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce a 30 MPH speed limit on Broad Street (B2184) in Cuckfield, from its junction with the A272, northwards to the existing 30 MPH speed limit at its junction with Denning Place.

The Order also consolidates the existing 40 MPH Speed Limits on the A272 between the roundabouts at its junction with Broad Street and Isaacs Lane. This part of the Order makes no changes to the current speed limits on this part of the road.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will introduce a 30 MPH speed limit on Broad Street (B2184) in Cuckfield, from its junction with the A272, northwards to the existing 30 MPH speed limit at its junction with Denning Place.

Broad Street is presently subject to a 40 MPH Speed limit between the A272 and its junction with Denning Place. Local residents have requested that this short length of speed limit be lowered to 30 MPH to improve safety and improve compliance with the current 30 MPH speed limit through Cuckfield.

This request has been assessed against the West Sussex County Council Speed Limit Policy and complies with the assessment criteria for a 30 MPH speed limit. It is considered that lowering the speed limit will improve road safety for vulnerable road users such as pedestrians and cyclists.

The current 40 MPH speed limit Order for Broad Street was made at a time the road formed part of the A272, and also enacts current speed limits on the A272 between Broad Street and Isaacs Lane. These speed limits are consolidated into the new Order for housekeeping purposes.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawing, numbered MDS2307 shows the length of road affected by the proposed order.

(A272 SPEED LIMITS CONSOLIDATION)
ORDER 2023

West Sussex County Council in exercise of their powers under Section 84 (1) a of the Road Traffic Regulation Act 1984 ("the Act"), and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

1. This Order shall come into operation on the ***** day of ***** and may be cited as "West Sussex County Council (Cuckfield) (Broad Street (B2184): Restricted Road) and (A272 Speed Limits Consolidation) Order 2023"
2. The Order Specified in the First Schedule to this Order is hereby revoked.
3. The length of road specified in the Second Schedule to this Order shall be a restricted road for the purpose of Section 82 of the Act.
4. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 Miles Per Hour in the lengths of roads specified in the Third Schedule to this Order.
5. Nothing in Paragraphs 3 or 4 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when –
 - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
 - (b) the vehicle is being driven-
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds.

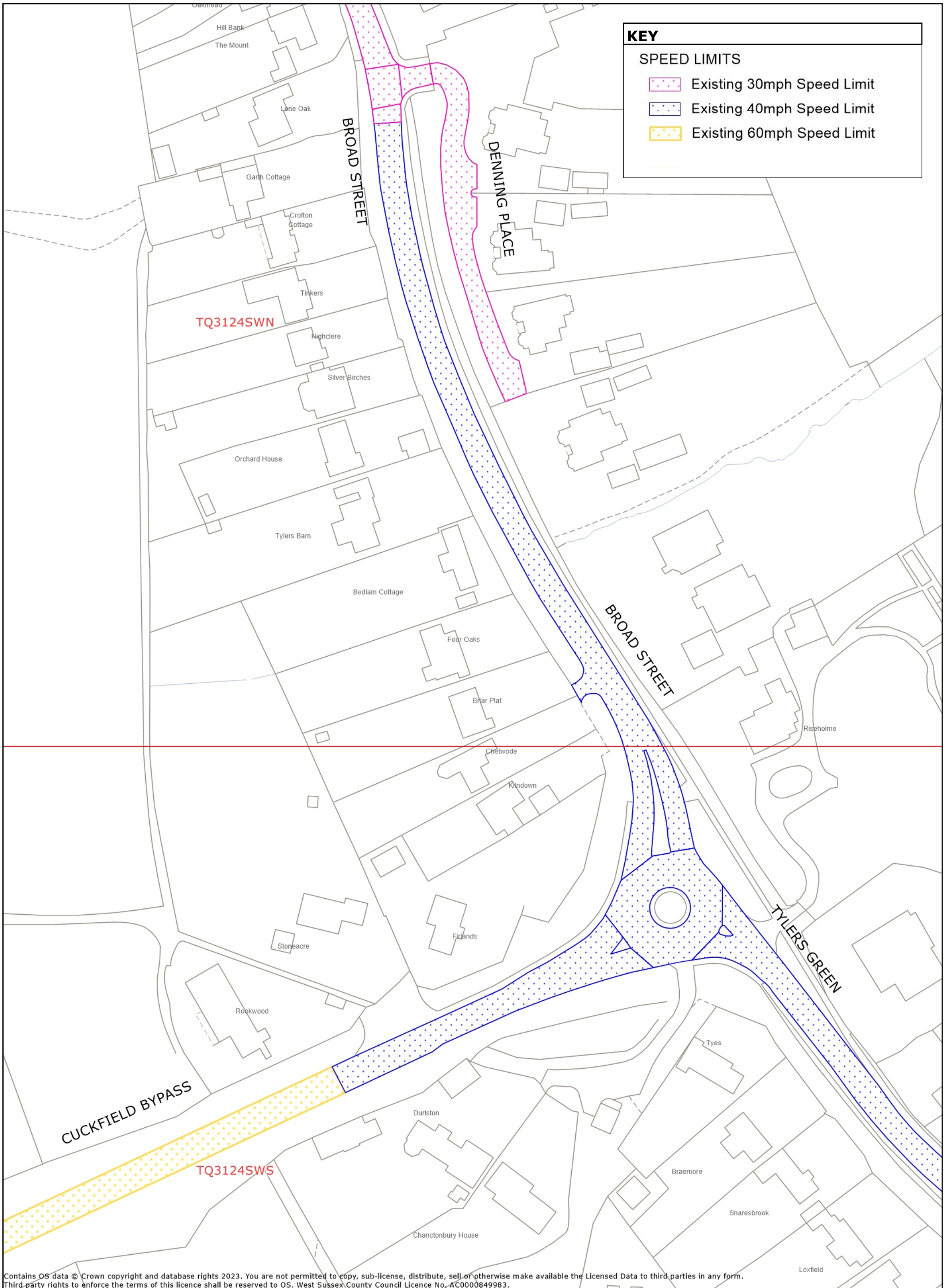

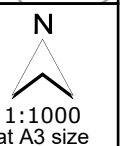


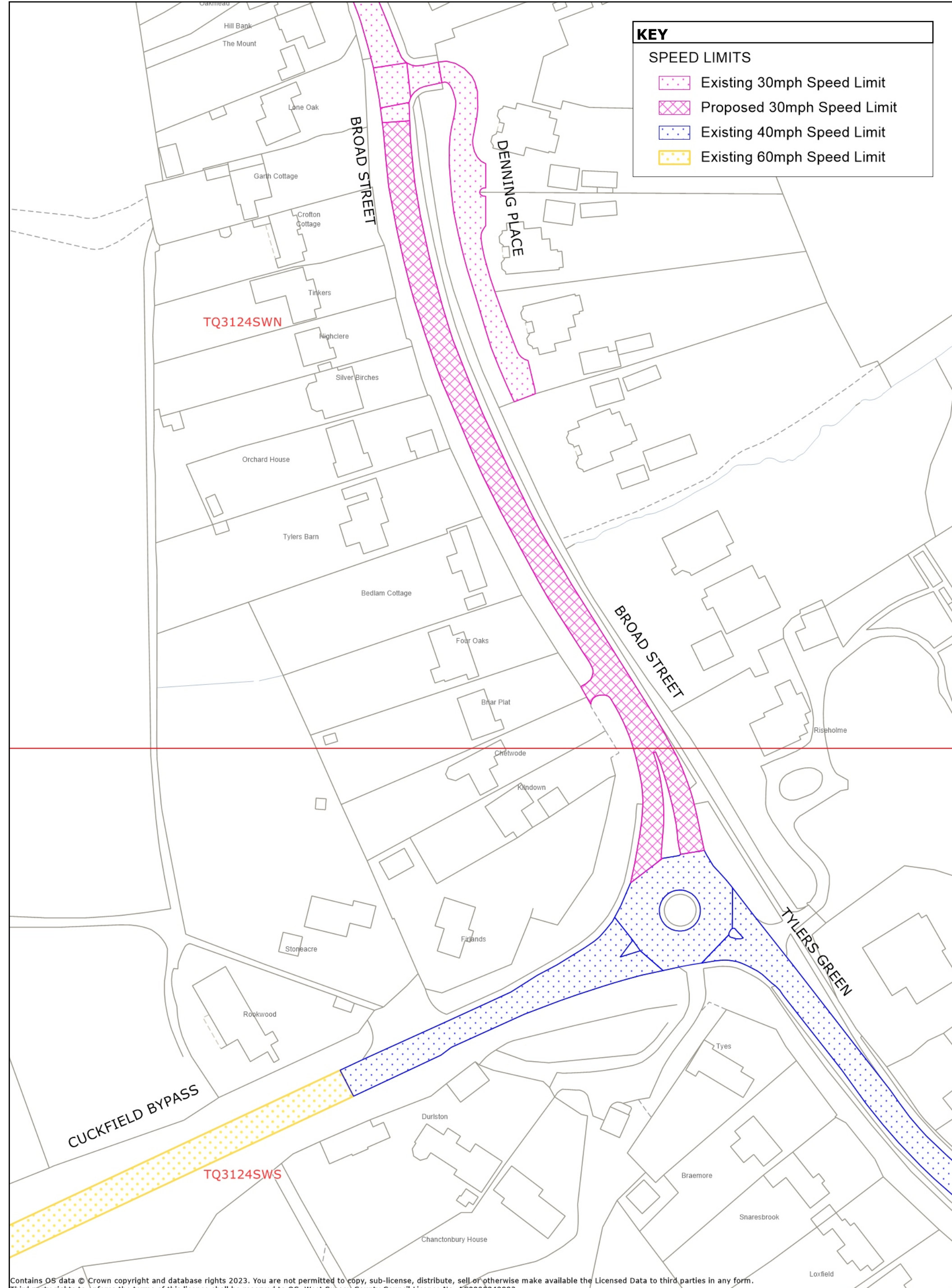
