Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) at a new junction giving access to a property development being bult on land west of the Mayberry Garden Centre.




