## **Introduction**

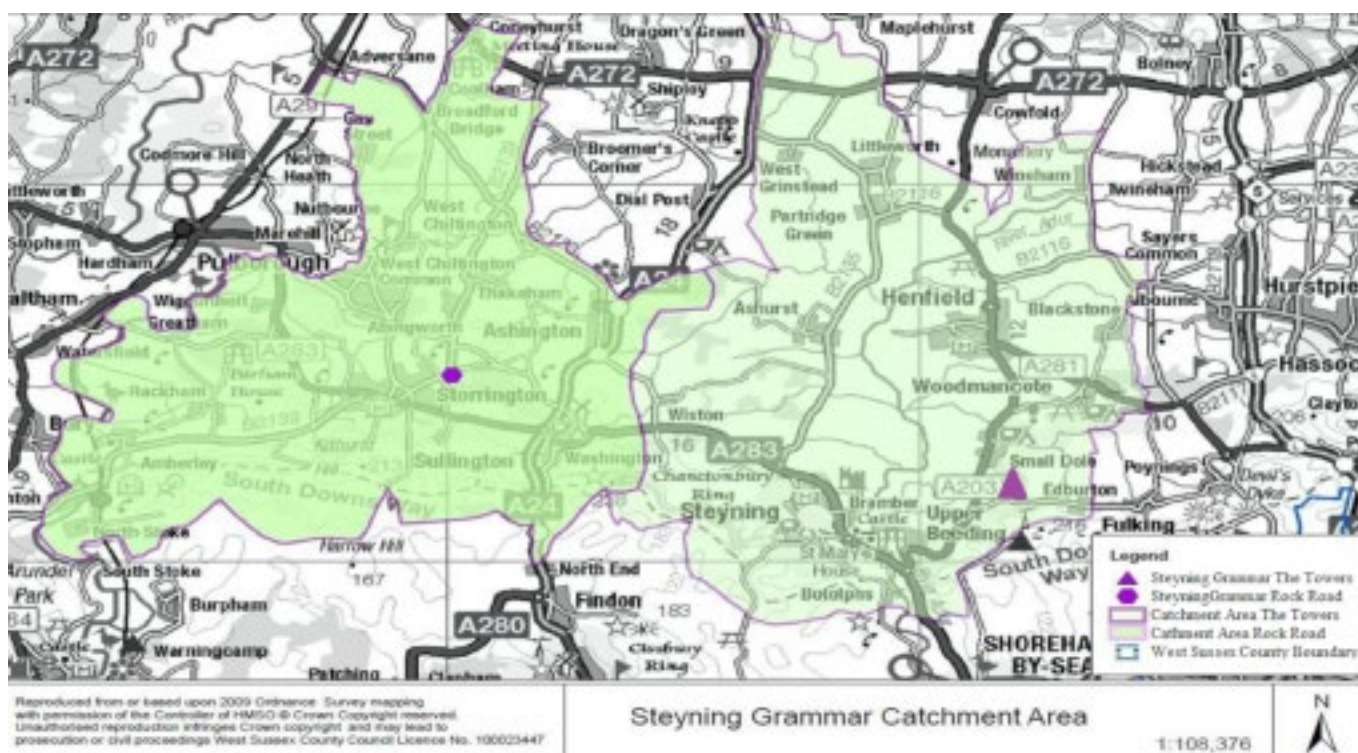

### **Steyning Grammar School – Children living within catchment**
