NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) at the junction of Street Lane with Holmans in Ardingly.

The Order also makes short extensions to existing double yellow lines on the southern side of Street Lane near The Ardingly Inn, and on the eastern side of the section of Street Lane which runs from opposite the Ardingly Inn to High Street.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) at the junction of Street Lane with Holmans in Ardingly.

The Order also makes short extensions to existing double yellow lines on the southern side of Street Lane near The Ardingly Inn, and on the eastern side of the section of Street Lane which runs from opposite the Ardingly Inn to High Street.

Ardingly Parish council have applied for a community highways scheme for footway improvements and the provision of safe pedestrian crossing points on Street Lane. The restrictions enacted by this order are needed to ensure parked vehicles do not obstruct the vision of pedestrians crossing the road and to improve visibility of pedestrians to passing traffic.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to preserve or improve the amenities of the area through which the road runs.

The attached drawings, numbered TQ3429NWS and TQ3429SEN show the lengths of roads affected by the proposed order.








