Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) on both sides of College Lane and Wickham Drive at their junction in the parish of Hurstpierpoint and Sayers Common.

A new cycle route is being developed to run from Sayers Common to Hurstpierpoint. This passes through the junction of College Lane with Wickham Drive and it has been identified that vehicles parking too close to the junction limit the vision of traffic and would create a hazard for cyclists using the new route, as well as to other road users.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawings, numbered TQ2916SWN and TQ2916SWS show the lengths of roads affected by the proposed order.




