NOTICE is hereby given that in exercise of their powers under the Road Traffic Regulation Act 1984, West Sussex County Council, propose to make a permanent Order the effect of which will be to introduce 3 lengths of prohibition of waiting (double yellow lines) on the west side of Lavant Road:-

- (i) north of the junction with Maddoxwood; and
- (ii) across the entrance to the refuelling station between Maddoxwood and Roman Fields; and
- (iii) south of the junction with Roman Fields.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce 3 lengths of prohibition of waiting (double yellow lines) on the west side of Lavant Road:-

- (i) north of the junction with Maddoxwood; and
- (ii) across the entrance to the refuelling station between Maddoxwood and Roman Fields; and
- (iii) south of the junction with Roman Fields.

Lavant Road is an 'A' classified single carriageway road. Parking issues have been reported around the junctions with Maddoxwood and Roman Fields. These issues are primarily attributable to vehicles, including HGVs, being parked to access the fuelling station. Vehicles parked on the verge/footway have caused maintenance defects and means that vulnerable road users in the form of pedestrians are having to walk around parked vehicles, into oncoming traffic.

At the time planning permission was granted for the residential development on land to the west of Maddoxwood Cottage it was recommended in the Road Safety Audit that parking restrictions be introduced to prevent verge parking within the visibility splay.

It is proposed to introduce lengths of double yellow lines north of Maddoxwood, south of Roman Fields and across the refuelling station entrance. The double yellow lines apply to the full extent of the highway so aims to deter parking on the verges and footways as well as the carriageway.

The Order is proposed for avoiding danger to persons or traffic using the road and to prevent the likelihood of any such danger arising, for preventing damage to the road and for facilitating passage on the road of any class of traffic including pedestrians.






PAGE 1 OF 2: EXISTING RESTRICTIONS ONLY
