**NOTICE** is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to extend the 30mph speed limit on the unlit section of Monks Hill from Pippins northwards for a distance of 262 metres.

# WEST SUSSEX COUNTY COUNCIL (WESTBOURNE: MONKS HILL) (30MPH SPEED LIMIT) ORDER 202\*

#### **Statement Of Reasons For Proposing To Make The Order**

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to extend the 30mph speed limit on the unlit section of Monks Hill from Pippins northwards for a distance of 262 metres.

Monks Hill runs north-south between North Street and Emsworth Common Road providing access to Westbourne village and the hamlet of Aldsworth. The southern section of Monks Hill is within the built-up area of the village and subject to a 20mph speed limit, a 30mph speed limit applies on a section of the road with a system of streetlighting and then north of the street lit section the road becomes de-restricted. On the eastern side of Monks Hill where the road is de-restricted is a recreational ground and childrens play park.

Concerns have been raised locally about road safety and general traffic speed due to the high numbers of vulnerable road users. The Parish Council have requested that the 30mph speed limit be extended northwards so that the play park is within the restricted area.

This Order is proposed so as to reduce danger to persons or other traffic using the road or to minimise the likelihood of any such danger arising, and for preserving or improving the amenity of the area through which the road runs.

Drawing CHI2306 Westbourne – Monks Hill proposed speed limits shows the length of road, which is the subject of the proposed order.

# WEST SUSSEX COUNTY COUNCIL (WESTBOURNE: MONKS HILL) (30MPH SPEED LIMIT) ORDER 202\*

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the x day of x 202\* and may be cited as "West Sussex County Council (Westbourne: Monks Hill) (30mph Speed Limit) Order 202\*"
- 2. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of road specified in the Schedule to this Order
- 3. Nothing in Paragraph 2 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.
