- a 20mph speed limit on lengths of Itchenor Road, The Street and Shipton Green Lane; and
- a 30mph speed limit on lengths of Itchenor Road and Shipton Green Lane.

## WEST SUSSEX COUNTY COUNCIL (WEST ITCHENOR, BIRDHAM & WEST WITTERING: ITCHENOR ROAD & ADJOINING ROADS) (20MPH & 30MPH SPEED LIMIT) ORDER 202\*

#### **Statement Of Reasons For Proposing To Make The Order**

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce:

- a 20mph speed limit on lengths of Itchenor Road, The Street and Shipton Green Lane; and
- a 30mph speed limit on lengths of Itchenor Road and Shipton Green Lane.

Concerns have been raised locally by the Parish Council about road safety in West Itchenor village. West Itchenor has limited road width and a high presence of vulnerable road users, with limited pedestrian facilities along the village roads. It is noted that the village roads are well used by pedestrians accessing the harbour amenities at the northern end. The village speed limit is currently 30mph.

The Parish Council have requested that a village wide speed reduction be introduced reducing the 30mph speed limit to 20mph and introducing a 30mph speed limit on the derestricted sections of roads on the approaches to the village from the B2179.

The application has been assessed in accordance with the West Sussex Speed Limit Policy. A 20mph is considered appropriate in the village where the roads are narrow with bends and hedges. Additionally, to slow traffic on the southern approaches to the village it is proposed to introduce 30mph speed limits on lengths of Itchenor Road and Shipton Green Lane from the B2179 northwards to the 20mph in the village.

To encourage compliance with the reduced speed limits it is proposed that repeater signs will be installed at regular intervals along sections of road where the 20mph speed limits will apply.

This Order is proposed for avoiding danger to persons using the road or avoiding the likelihood of any such danger arising, for facilitating safe passage on the road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road runs.

Drawing CHI2502 Itchenor Road proposed speed limit (21.07,2025) proposed speed limits shows the length of road, which is the subject of the proposed order.

## WEST SUSSEX COUNTY COUNCIL (WEST ITCHENOR, BIRDHAM & WEST WITTERING: ITCHENOR ROAD & ADJOINING ROADS) (20MPH & 30MPH SPEED LIMIT) ORDER 202\*

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the x day of x 202\* and may be cited as "West Sussex County Council (West Itchenor, Birdham & West Wittering: Itchenor Road & Adjoining Roads) (20mph & 30mph Speed Limit) Order 202\*"
- 2. The Order in the First Schedule to this Order shall be revoked.
- 3. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour in the lengths of roads specified in the Second Schedule to this Order
- 4. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of road specified in the Third Schedule to this Order
- 5. Nothing in Paragraphs 3 and 4 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.
