**NOTICE** is hereby given that West Sussex County Council proposes to introduce a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to reduce the speed limit to 30mph on the length of the Rogate Road from the B2070 London Road at the Hampshire County boundary, south-eastwards for a distance of 420 metres and on Knowles Meadow.

## WEST SUSSEX COUNTY COUNCIL (ROGATE – HILL BROW: ROGATE ROAD) (30MPH SPEED LIMIT) ORDER 2024

West Sussex County Council in exercise of their powers under Sections 82 and 84 (1) (a) of the Road Traffic Regulation Act 1984 ("the Act"), and Part IV of Schedule 9 of the Act and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III and Part IV of Schedule 9 to the Act hereby make the following Order:-

- This Order shall come into operation on the x day of x 2024 and may be cited as "West Sussex County Council (Rogate – Hill Brow: Rogate Road) (30mph Speed Limit) Order 2024"
- 2. The Order in the First Schedule to this Order is hereby revoked.
- 3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour on the length of road specified in the Second Schedule to this Order.
- 4. Nothing in Paragraph 3 shall apply to a vehicle being used by naval, military or air force purposes while being driven by a person for the timebeing subject to the orders of a member of the armed forces of the Crown on an occasion when
  - (a) the person driving the vehicle is a member of the special forces as defined by the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011; and
  - (b) the vehicle is being driven-
    - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving vehicles at high speeds; or
    - (ii) for the purpose of training a person in driving vehicles at high speeds.


