NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on both sides of Parkfield Way in Bolnore Village, Haywards Heath from the road narrowing feature at its junction with Trubwick Avenue, westwards for 35m.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) on both sides of Parkfield Way in Bolnore Village, Haywards Heath from the road narrowing feature at its junction with Trubwick Avenue, westwards for 35m.

A local resident has applied for a community Traffic Regulation Order for the proposed restrictions to improve visibility and safety on the eastbound approach to the road narrowing feature between Parkfield Way and Trubwick Avenue. There is a bend in the road at this location and parked vehicles prevent eastbound vehicles seeing whether there is westbound traffic approaching through the road narrowing.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawing, numbered TQ3223SWN shows the length of road affected by the proposed order.




