(Burgess Hill: Munns Drive & Leylands Road Amendment) Order 2024 Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) at the junction of Munns Drive with Leylands Road in Burgess Hill.

Residents have made an application to West Sussex County Council for new parking restrictions to ensure drivers emerging onto Leylands Road from Munns Drive are able to see approaching traffic. Preventing parking close to the junction will also improve pedestrian safety.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road.

The attached drawing, numbered TQ3119NEN shows the lengths of roads affected by the proposed order.




