## **Notice of Adoption of Local Plan (Regulation 26)**

## Town and Country Planning (Local Planning) (England) Regulations 2012

In accordance with the Regulations set out above, this Adoption Statement gives notice that West Sussex County Council and South Downs National Park Authority formally adopted the West Sussex Waste Local Plan on 11 April 2014.

The West Sussex Waste Local Plan is the principal document for the determination of applications for waste management uses. The Plan covers the period to 2031, and sets out the background, the spatial context and the strategy and policy context within which it has been prepared. It includes a vision and strategic objectives, land-use strategies, use-specific and general development management policies, the allocation of five sites for built waste management facilities and one site for non-inert landfill, and implementation and monitoring information.

The Plan was subject to an Examination in Public, by an independent planning inspector, during July 2013. The Planning Inspector issued his report on 17 February 2014, and deemed the Plan to be sound and legally compliant, subject to modifications. The adopted Plan incorporates the Main Modifications, and a number of minor modifications.

Any person aggrieved by the Plan may make an application to the High Court under the Planning and Compulsory Purchase Act 2004 section 113 on the ground that;

- (a) the Plan is not within the appropriate power;
- (b) a procedural requirement has not been complied with.

An application must be made no later than the end of the period of six weeks starting from the date the Plan was adopted. The period ends on Friday 23 May 2014.

The Plan cannot be questioned in any legal proceedings except in so far as is provided by section 113.
