STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to make a permanent Order the effect of which will be to introduce a length of prohibition of waiting (double yellow lines) on the south-west side of Seymour Mews.

Planning permission was granted by the Southdowns National Park Authority for 34 dwellings on land at Rotherlea south of Dawtrey Road, Petworth. The access road is Seymour Mews. Parking on the turning head at the end of Seymour Mews is common place and is causing larger vehicles to overrun the kerb. The Road Safety Auditor has recommended a length of double yellow lines be introduced on the south-west side of Seymour Mews to deter parking in this location.

The Order is proposed so as to prevent damage to the road, for facilitating the safe passage of any class of traffic (including pedestrians) and for improving the amenity of the area through which the road runs.

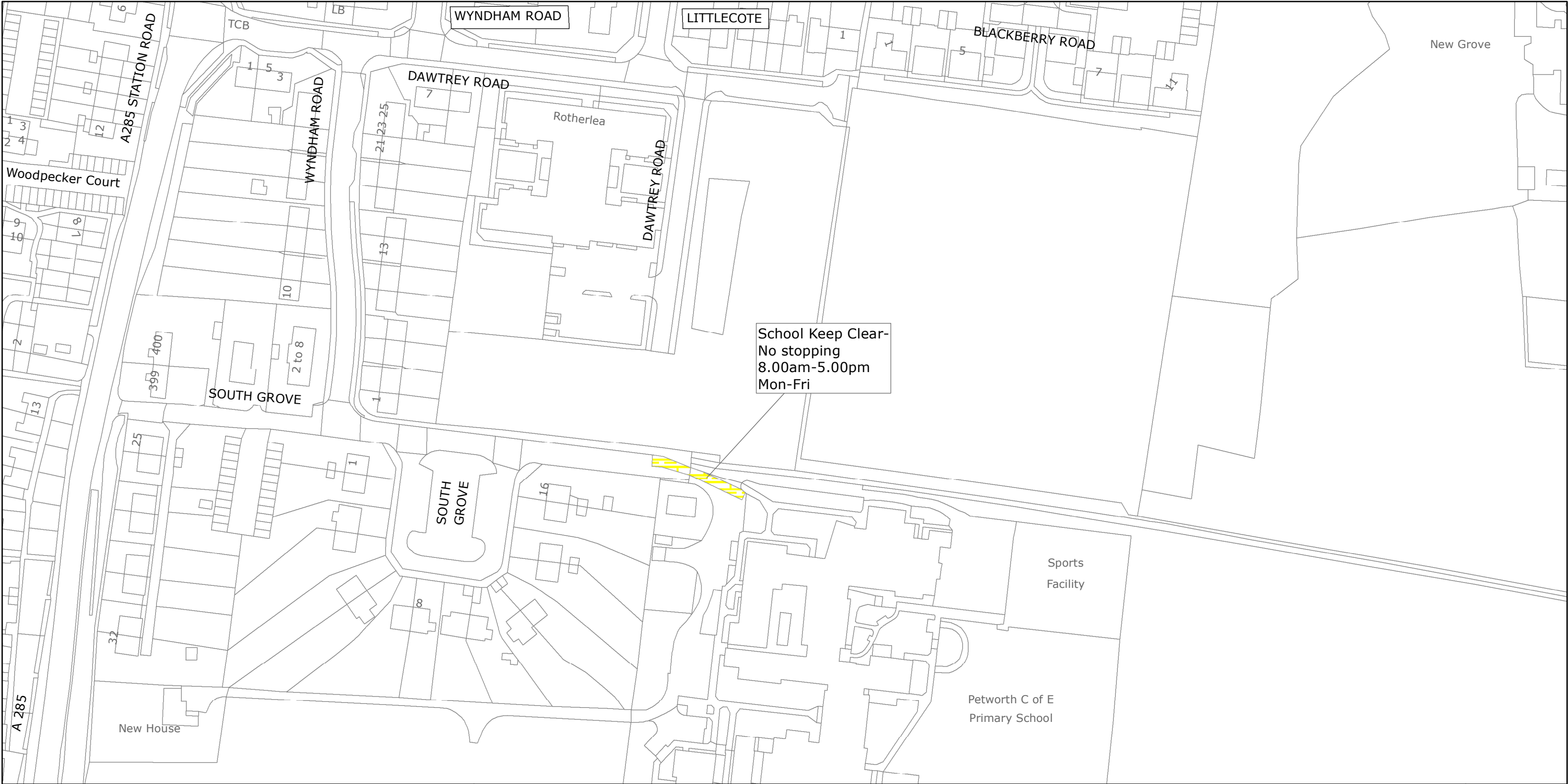
