NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit motor caravans waiting in any of the currently unrestricted parking places in Mill Road, Arundel between 10pm and 9am on any day.

(Arundel: Mill Road Amendment) Order 2024

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit motor caravans waiting in any of the currently unrestricted parking places in Mill Road, Arundel between 10pm and 9am on any day.

Arundel Town Council have received complaints from residents that Mill Road is frequently used for camping trips by people in campervans. There are no proper sanitary facilities to accommodate this and long stay parking by such vehicles reduces availability of parking for other visitors to the area.

Although camping on the public highway is unlawful, enforcement action is often ineffective because vehicles move on before the legal process can be completed. The introduction of a parking restriction allows local parking officers to immediately issue penalty charge notices to contravening vehicles, which is considered a more effective deterrent.

It is therefore proposed to introduce a parking restriction prohibiting motor caravans from parking in the road overnight. This will allow daytime visitors in campervans to access the area, but prevent the road being used for overnight camping.

The new order is therefore proposed to preserve or improve the amenities of the area through which the road runs.

The attached drawings, numbered TQ0107NEN, TQ0107NES, TQ0108SES, TQ0207NWS, TQ0207SWN and TQ0207SWS show the lengths of roads affected by the proposed order.

West Sussex County Council in exercise of their powers under Sections 1 (a) 2 (1) and (2), 4 (2), 45, 46, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-
