#### STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of the north side of Church Road.

Church Road is a busy 'D' class cul-de-sac road in the Lowfield Heath Industrial Estate in close proximity to Gatwick Airport. The current on-street parking causes localised obstruction and access difficulties for business deliveries. It is common place for vehicles to park in too close proximity to junctions to the detriment of safe visibility for vehicles exiting and entering the commercial premises. The Council received a request from local businesses to address this issue.

To alleviate the problem, it is proposed to introduce lengths of double yellow lines in and around three accesses on the north side of Church Road. The parking restriction will deter parking in those locations where it creates an obstruction and restricts visibility. This will enable vehicular movements to be made more safely.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road runs.




