NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on the southern side of Courtwick Road in Littlehampton at its junction with Selwyn Avenue. This restriction would also extend southwards a short distance along both sides of Selwyn Avenue.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting at any time (introduce double yellow lines) on the southern side of Courtwick Road in Littlehampton at its junction with Selwyn Avenue. This restriction would also extend southwards a short distance along both sides of Selwyn Avenue.

West Sussex County Council has received a community TRO application asking for parking restrictions to address problems caused by vehicles parking too close to the junction of Courtwick Road with Selwyn Avenue. These parked vehicles cause a hazard by obstructing visibility for traffic passing through the junction and cause obstruction by preventing vehicles travelling in opposite directions from passing.

The new order is therefore proposed to avoid danger to persons or other traffic using the affected lengths of road and to facilitate the passage of traffic.

The attached drawings, numbered TQ0203SEN and TQ0203SES show the lengths of roads affected by the proposed order.








