NOTICE is hereby given that West Sussex County Council proposes to make a permanent Traffic regulation Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at any time (introduce double yellow lines) on roads in Pease Pottage as follows:

Belleview Farm Road: throughout the whole western side of the road between Grace Holland Avenue and Stanford Brook Way; the whole northern side of the road between Stanford Brook Way and Oswald Norris Way, the whole eastern side of the road between Oswald Norris Way and Grace Holland Avenue; and

Grace Holland Avenue: Throughout the whole southern side of the road; and

Cordingley Drive, Oswald Norris Way, Stanford Brook Way (southern junction), William Belt Road, at their junctions with Belleview Farm Road and Thorn Way at its junction with Grace Holland Avenue.

The Order also adjusts the existing order enacting parking restrictions on Bensons Hill Road to include an existing parking bay for disabled persons' blue badge holders.

Statement of Reasons for Proposing to Make the Order

West Sussex County Council proposes to make a permanent Traffic Regulation Order that will prohibit waiting on both sides of roads in Pease Pottage as follows:

Belleview Farm Road: throughout the whole western side of the road between Grace Holland Avenue and Stanford Brook Way; the whole northern side of the road between Stanford Brook Way and Oswald Norris Way, the whole eastern side of the road between Oswald Norris Way and Grace Holland Avenue; and

Grace Holland Avenue: Throughout the whole southern side of the road; and

Cordingley Drive, Oswald Norris Way, Stanford Brook Way (southern junction), William Belt Road, at their junctions with Belleview Farm Road and Thorn Way at its junction with Grace Holland Avenue.

The affected roads are located within the recently constructed Woodgate development east of the A23 at Pease Pottage. A new bus route serving the development is due to operate though Belleview Farm Road and Grave Holland Avenue and it has been identified that buses will be obstructed by parked cars unless parking restrictions are installed.

The proposed yellow lines are extended a short distance into side roads to preserve visibility at their junctions with Belleview Farm Road and Grace Holland Avenue.

The proposed Order also adjusts enacts an existing parking bay for disabled persons' blue badge holders on the western side of Bensons Hill Road. This bay is already installed on site but is not supported by the current parking order.

The new order is therefore proposed to facilitate the passage of traffic and improve the amenities of the area through which the road runs.

The attached drawings, numbered TQ2633SEN and TQ2633SES show the lengths of roads affected by the proposed order.




