NOTICE is hereby given that West Sussex County Council propose to make a permanent Order under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of Findon Road, east of the junction with Warren Drive and on the east side of Warren Drive, north and south of the junction with Findon Road.

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of both sides of Findon Road, east of the junction with Warren Drive and on the east side of Warren Drive, north and south of the junction with Findon Road.

Findon Road is a 'D' class residential road in the vicinity of St. Margarets Primary school. The road has a narrow width and provides access to numerous properties and flats. Current on-street parking practice is causing localised obstruction and access difficulties. Vehicles are frequently parking in too close proximity to the junction with Warren Drive which affects forward visibility for all road users. This has resulted in safety issues for pedestrians as well as obstructing vehicular access for deliveries and local residents. The Council received a request from local residents to address this issue.

To alleviate the problem, it is proposed to introduce lengths of double yellow lines in and around the junction of Findon Road with Warren Drive. The parking restriction will deter parking in those locations where it creates an obstruction. This will improve visibility and make the road safer for all road users.

This Order is proposed for avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising and for facilitating the passage on the road or any other road of any class of traffic (including pedestrians) and for preserving or improving the amenity of the area through which the road runs.

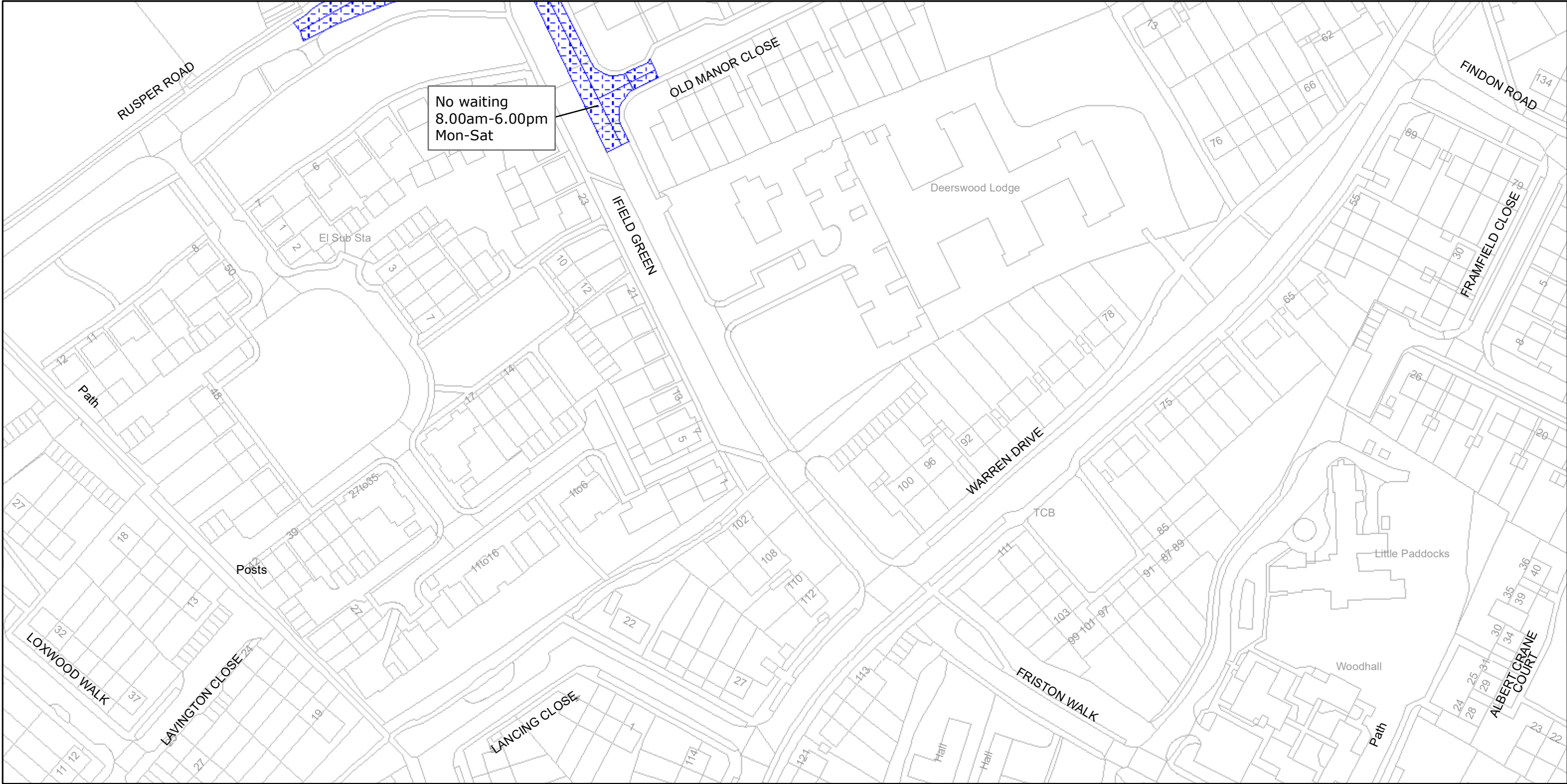
