Introduction

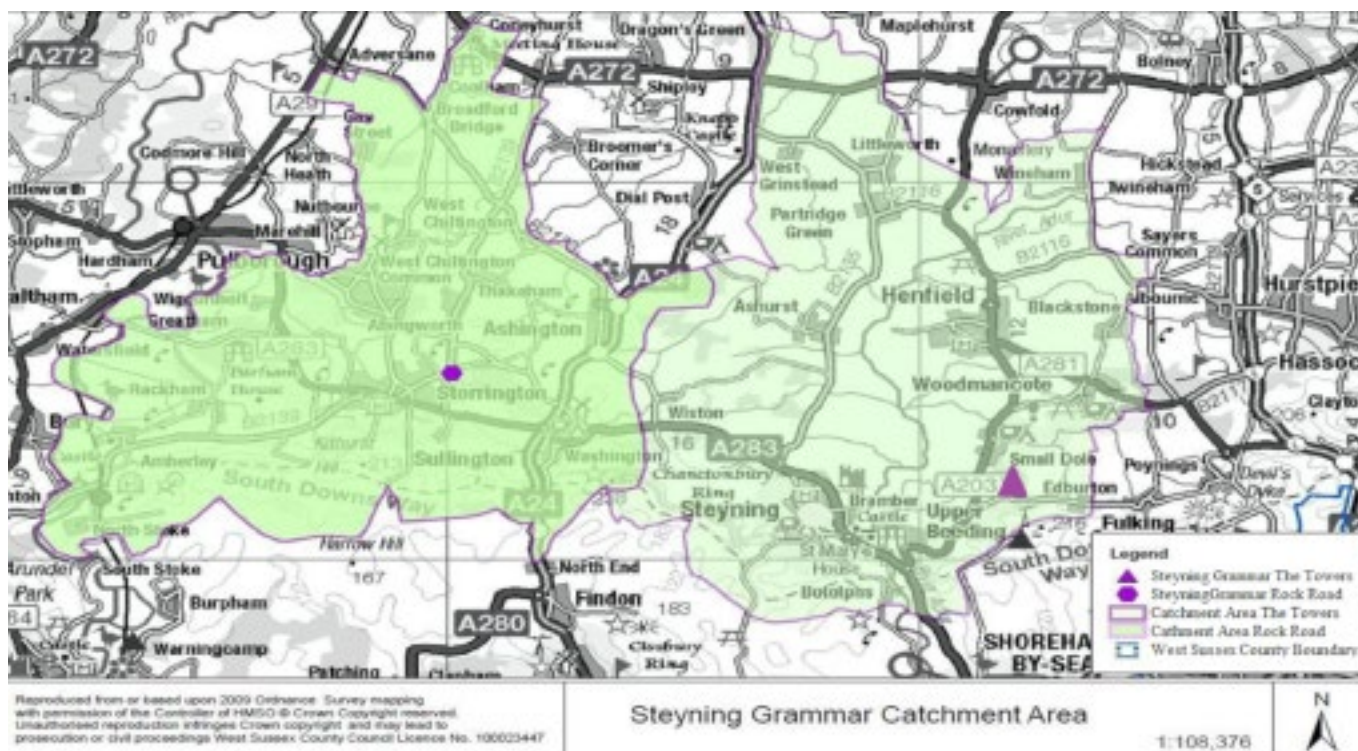
